## Minutes of December 6 meeting

Councilwoman Scarbrough moved to approve noting changes, second by Councilman Mohr. Yeas: Scarbrough, Leonard, Mohr, and Utz. Nays: None. Abstain: Jasionowski. Motion carried by 4/0 vote.

# Police Report

Sgt. Roop reported (see attached.) Councilman Jasionowski asked Sgt. Roop if the Police Department can crack down on speeding in Greenhill Crossing.

Councilman Jasionowski asked about the business district issue. Mayor Kapp reports he spoke with VDOT who will call

**Land Disturbing Permit** 

<u>Leaberry</u>, 15201 Washington Street – Mr. Leaberry states there is bad dirt on this lot and he would like to be able to stockpile new dirt over ninety day period, from today. Mr. Leaberry agrees to pay site inspections billed by BD&E. Councilwoman Leonard asked the definition of stockpiling. Mr. Leaberry states it will look no worse than it does now.

Ralph Ring would like to have the design guidelines and the historic overlay ordinance for the Greenhill Crossing ARC to review.

#### **Planing Commission**

Councilwoman Scarbrough states there was no meeting due to any business being submitted.

#### Architectural Review Board

Councilwoman Leonard states there was no meeting due to lack of quorum. Councilwoman Leonard would like to meet on Thursdays due to church conflicts for members.

Certificate of Appropriateness

18<sup>th</sup> Century Havmarket - Barrington & Sheldon - Councilwoman Leonard states Mr. Foley looked at the elevations and said they were okay. Councilman Mohr clarifies there are two lights on the houses and two lights on the garage and garage would face street not to the back.

Mr. Pressman, Ryan Homes, submitted a site plan laying out all Barringtons to show where he needs help on lots 2 & 6, Barrington is the wider of two homes (Sheldon & Barrington) – shows where we will need waivers on set back for existing zoning. There is a 5'-7' variations in the placement of homes on the front. Lots 2 & 6 have been worked out with minor waivers.

Ryan would like to get general approval for lots as per this site plan. Councilwoman Leonard asks about dentil molding planned. Will it be like Greenhill Crossing dentil molding or more like Equity Homes (heavier dentil molding). Mr. Pressman will look for a heavier dentil molding for submission to the ARB.

Councilman Utz states he is glad it is coming to a conclusion and everyone is winning.

# Barrington - A, B, C

Councilman Jasionowski moved to approve A&B with dormers, with or without brick, with colonial lintels, carriage lights & heavier dentil molding and only on lots 2 & 6, second by Councilwoman Leonard. Councilwoman Scarbrough asks why on just those two lots. Councilman Mohr thinks these houses are fine for all lots. Councilwoman Leonard says the mission of the ARB and Historic Overlay is to create the image. Councilman Utz says the detached garage adds a colonial look. Councilman Jasionowski withdraws the two lot requirement and moved to approve for lots 2 & 6 through 16 with two lights on garages. Councilman Mohr wants to know about porches. Yeas: Scarbrough, Leonard, Mohr, and Utz. Nays: Jasionowski. Motion carried by 4/1 vote.

Councilman Mohr moved to allow Barrington porches be considered for Jefferson Street (elevation c), second by Councilwoman Scarbrough. Yeas: Scarbrough, Utz, and Mohr. Nays: Jasionowski, Leonard. Motion carried by 3/2 vote.

# Sheldon - A. B. C.

Councilman Jasionowski moved to approve elevation A only with dormers, with or without brick. Sheldon B with or without brick only on lots 2, 6 through 16, with colonial lintels, carriage lights, dentil molding, second by Councilman Utz. Wood look siding only. Yeas: :Scarbrough, Leonard, Mohr, and Utz. Nays: Jasionowski Motion carried by 4/1 vote.

Councilman Mohr moved to approve Sheldon C (porch) only with dormers with colonial lintels, carriage lights & dentil molding on Jefferson Street, second by Councilman Utz. Yeas: Scarbrough, Leonard, Mohr, and Utz. Nays: Jasionowski. Motion carried by 4/1 vote.

Mr. Pressman, Ryan Homes, thanked the Town Council, Architectural Review Board and the Historical Commission for sticking with them and look forward to working here.

Councilman Utz asked about site improvements for lot 1, it needs to be cleaned up. Mr. Bolt states he doesn't own that house. Mayor Kapp says it needs cleaning up.

**Board of Zoning Appeals** 

Councilman Mohr moved to adopt state code reference and town code reference 13 to 12-274 for notice of appeals, second by Councilman Utz. Yeas: Scarbrough, Leonard, Mohr, Utz, and Jasionowski. Nays: None. Motion carried by 5/0 vote.

### **Historical Commission**

Mrs. Crafton-Masterson reported (see attached). She has contacted the Historic Resource group in Winchester and received their guildeines and understands they received a federal grant.

<u>Bicentennial Tea</u> – Saturday January 8, 4:00 to 6:00 p.m. at St. Paul's Parish Hall. Need financial help (\$200). Councilman Mohr moved to approve \$200 for tea, second by Councilwoman Leonard. Yeas: Scarbrough, Leonard, Mohr, Utz, and Jasionowski. Nays: None. Motion carried by 5/0 vote.

<u>Historical Commission bylaws</u> – Mrs. Crafton-Masterson asks for approval. Councilman Mohr states only change is the suppositions and the term and added up to ten positions.

Councilman Jasionowski suggests article 3 he would like to see the word "direct" change to "advise." Mrs. Crafton-Masterson states her version was "counsel and assistance" (also in paragraph two)

Councilman Jasionowski asks Mrs. Crafton-Masterson is there value in listing each and everyone of these titles in case of vacancies. Mrs. Crafton-Masterson stay that was her original suggestion but it was suggested that each person be recorded with a position.

Councilman Jasionowski suggests the chairman, vice chairman be listed as titles and let the Historical Commission handle any other positions, not official titles.

Councilman Mohr moved to approve bylaws with amendments, second by Councilwoman Scarbrough. Yeas: Scarbrough, Leonard, Mohr, Utz, and Jasionowski. Nays: None. Motion carried by 5/0 vote.
