Budget

Police Dept. - Sgt Bockey states the Police Department wants \$1500 for uniforms. \$4000 alloted for vehicle maintenance, \$3500 for fuel, \$1000 for telephone. 3% step raise was figured in new police officer salary. 75% government support for year one - \$23,500 salary, \$4209 benefits = \$27,70, \$23,435 government share, 50% government support for year two - \$24,205 salary benefits = \$28,486, \$22,075 government share and \$25% government support for year three - \$24,931 salary plus benefits = \$29,287, \$18,602 government share. Total government for three years \$64,112.

Councilwoman Leonard states she got a estimated quote of about \$250 per person for health insurance.

Collator for copier - Town Clerk to get proposal for collator.

Accounting software - Town Clerk advised Council the Southern Software company wants \$1275 per year for support for the CitiPak software. She suggested the town switch to Peach Tree accounting software, which is an industry standard, that would take care of the town business. She further stated the County has not gotten the new computer program which will allow the town to access information for tax billing.

<u>Historical Commission</u> - raise to \$3000, \$1200 for Historic Commission operation, \$960 for Town Council liaison and \$720 for Historic Commission chairman.
