Cole addresses council with regard to the meals tax. He comments that we cannot move forward on any other plans with this budget standing alone. To the business owners: Period and often advertising for the businesses. A quarterly advertisement system will be put into place. 4% meals tax proposed, 65% of the Towns in VA have a meals tax. We will lower the real property tax 1.5 cents. We must create the Town for people to want to come to it. We could lose over 1 million in grant funds if we don't spend the award monies. All monies from this tax minus advertising money would go to capital improvements.

Vazquez asks if council would consider not reducing the real property tax. He visited approx. 50 people in various areas. Only 1 person said they did not want the meal's tax. 20% of the people voluntarily othered to maintain the real property tax.

Weir feels it in intellectually distancest to not adopt the effective tax rate. He feels it should stay the same

Bennett comments that most jurisdictions have a reserve or a cushion.

Sikorsky comments that if we have a meal's tax it should be earmarked. How do we enforce that these monics get used for street scape even when this council is gone. Bennett responds that it is not possible for one body to bind another body with the exception of long term notes.
