



Mayor Kapp opened the regular meeting at 7:30 p.m.

**Minutes of April 6 and February Town Council/ARB work Session meetings**  
Vice Mayor Shepard moved to dispense with the reading of the minutes and approve the minutes with corrections noted, second by Councilwoman Scarbrough. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

**Petition to keep Mr. Lowery as Building Official.**  
Mayor Kapp accepted a petition from Mr. Lonnie Milstead, a resident of Greenhill Crossing.

**Police Report**  
Sgt. Bockey reported 49 traffic violations in April, 2 DWI, 25 calls answered.

Spring Festival - Sgt Bockey reports no problems noted. There was one complaint about the street being blocked by a business owner.

Prince William County new radios - Sgt Bockey has scheduled a meeting.

New Police Officer - applicants, 13 resume's received. Sgt Bockey narrowed it down to five applicants and has done the background check. He intends to have completed the check for the Thursday review by Council.

Councilman Seffinga asks when the grant goes into effect. Sgt Bockey doesn't know, he told them he expects to start new officer in June. Councilwoman Leonard states the committee wants to know will the Council want recommendations from the committee. Mayor Kapp states he would like to see qualifying applicants be recommended to Council. The Council wants to interview the finalists after the background checks eliminate some. Councilman Seffinga states if we are down to two qualified applicants at this point then we should get more applicants. Sgt Bockey says he has two good candidates. Mayor Kapp asked Sgt Bockey to contact the candidate that did not sign the release for background check.

Committee to meet and look over the background investigation and come up with a recommended list to Council. Council to interview Thursday, May 21 at 7:00 p.m. at Winterham.

New Codes - will be out in July. Sgt Bockey and Atty Jamison to meet and will incorporate in the Code.

General Orders - Atty Jamison says the Town Council does not have to adopt them. Council members should look through it. Councilwoman Scarbrough has reviewed the orders, no one else has. Sgt Bockey says he is reducing the type size and eliminating some redundant information to make it more compact.

**Planning Commission**

Councilman Branca states the work session for zoning code review and fee schedule is May 19. After comments by Councilman Seffinga made at the last Council meeting the PC went back to our current fee schedule and are refining the permit process. Also the rear yard set back in regard to decks has been discussed. The PC has recommended to allow decks to encroach up to 10' of property line up to 36" high and 15' of property line if over 36" high.

Councilman Branca states in regard to new appointments in July he will step down from PC Liaison.

**Architectural Review Board**

Councilwoman Leonard states she did not attend the last ARB meeting.

Councilwoman Leonard states the issue with US Home was they were not willing to put dental

molding on all the homes in violation, including the Avalon D, therefore the ARB met to look at the homes US Home's architect felt did not lend themselves to the addition of dental mold. Mr. Mallott states in February Avalon A&B were reviewed, March 12 the ARB approved A, C & D and in April rejected the Avalon D. The brochure has been printed excluding the B model that was denied. Mike Mallott states they were willing to put dental molding on the ones their architect recommended. Councilwoman Leonard states the Town Council and US Homes asked the ARB to reconsider. The ARB will come back to the Town Council. US Homes wants to clarify Avalon approvals. Councilwoman Leonard states Avalon A, C & D were approved with the addition of dental molding, carriage lights, and colonial lintels. If US Home is not willing to put the colonial embellishments according to US Homes architect then Avalon D is not approved for building. Councilman Branca asks if the decision today about the Avalon D. Mr. Bush states at the last Town Council meeting the motion was made regarding the Avalon D was disapproved when it was previously approved. Mike Mallott states that every elevation has dental molding on it now. US Home plans to put dental molding on all new construction in section 9. Councilman Seffinga asks if it is legal and feasible to re-approve these elevations as submitted. Councilman Seffinga moved to approve the Avalon A, C & D to include dental molding, colonial lintels and carriage lights. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

**Historical Commission**

Mrs. Turner brought back 800 Haymarket history books, by Robert Crewdson, from Betty Duley. She says we can sell these books and put the money in a fund to print new copies.

Mrs. Turner's new history book is at the Library of Congress for reference checking. She says it takes eight months to a year to get it back.

Councilman Branca states we should reprint the current books. We do not charge for it now. Mrs. Turner says the book was done under a federal grant. Mrs. Turner says the County will not print the book any longer.

Councilman Seffinga says we can print the current book at \$1 each. Mayor Kapp will check with the County and get back at the June meeting.

Mrs. Turner states Mr. Contessi of the Sons of the American Revolution are working up a program for surrounding areas for September 25th when Lafayette actually went through. Colonial crafters are planned. A professional public relations firm is to help with the event.

The Historical Commission would like to decorate the caboose and put up curtains, etc. Council suggests using magnetic curtain rods.

Mrs. Turner asked if Mr. Paxton will allow our use of the old funeral home for a visitors center.

Mayor Kapp states the Mayor of Charleston (at VDDA meeting) stated they don't let anyone tear anything down. They make really attractive places out of every property.

Mrs. Turner states they received their patches, they are checking with electoral officials.

Haymarket Day - how will Council ride in the parade. Councilwoman Leonard want the carriages here early before the parade. Public rides from 9:30 to 11:30. To be discussed.

Councilwoman Leonard will get a new list of Fairfax City crafters for flyers.

George Allen may be our grand marshal for Haymarket Day parade. We will also have a military band and a harpsichord.

Vice Mayor Shepard moved to reimburse Councilwoman Leonard \$350 for Haymarket Day horse drawn wagon for the 1997 parade, second by Councilman Seffinga. Councilman Seffinga questions if this is appropriate. Atty Jamison states it is probably okay. He thinks it was enough of a public festival. Yeas: Shepard, Scarbrough, Branca. Nays: None. Abstain: Leonard, Seffinga. Motion carried by 3/0 vote.

### **Building Inspector**

Greenhill Grading - Mr. Lowery states Council needs to come up with some final decisions. There is also a problem with Section 9, Lot 23 water running on Norton property on Jefferson Street. It is a Peterson Companies problem. US Home says it is not their problem. Little John Court is flooding. Councilman Branca and Mr. Lowery to set up a meeting. Mayor Kapp asked them to look at Edwards problem. Mr. Lowery will have George Kropp of BDE join them. They'll look at all of the lots.

Water Service Connection in town - Mr. Lowery called PWCSA, he will set up a computer generated system. Mr. Lowery will send them request on permit and they'll send him if they have paid the fee. What about the water district was the question of the Town Clerk. Mayor Kapp will talk to Mr. Darby.

Trailer on Noell property - temporary offices - have to be placed on a foundation and a skirt around. There is no such thing as temporary. Ryan Homes sales trailer was on a foundation. Atty Jamison states he can not find anything on it in the Code book. He states we better not allow in the business or residential zone, only allow in the Industrial zone. Councilwoman Leonard states since the Historic District Overlay covers the entire town they don't want that type structure anywhere in town.

State of Virginia shrink/swell soil policy - Mr. Lowery states a town policy is required to be adopted by July 1. Mr. Lowery states there is a seminar May 21 in Charlottesville he will attend and bring forth recommendations for Council. Haymarket is in a major shrink/swell area. Marine clay will shrink when dry, swell when wet causes house foundation movement. Greenhill is all rock, no clay. It is (shrink/swell) is in the industrial area (Sheetz). Councilwoman Leonard states we want to be sure we indeed have the problem. Mr. Lowery states House Joint Resolution 4026 states we will not receive construction plans without shrink/swell plan.

Prince William County mapped the County showing we are part of the shrink/swell. Councilman Branca wants to see what Mr. Lowery has and look at the County map. Mr. Lowery says after the conference he'll have information. Councilman Branca asked if it is by individual lot. Yes, unless it is a subdivision, states Mr. Lowery. Mr. Lowery says plans have to be certified by a geotechnical engineer.

ISO rating - has been sent in for their response.

Old Bank Cafe - project stopped until they submit a stairway drawing and the tenant build out.

Councilman Seffinga asked why they didn't put a floor in. Mr. Lowery says they are waiting for a tenant for the plumbing plans.

Town Hall floor - Mr. Lowery states the floor is finished. Mayor Kapp asked if they fixed the leak. Mr. Lowery says there is no water standing.

Mr. Lowery asked about the ceiling. He will install new tiles if the town will buy them.

Councilwoman Leonard states if we are going to do anything in there it was to be done right. Councilman Seffinga says the problem is all the wires and duct work. Mayor Kapp will check on price of ceiling tile for June meeting.

ARB vacancy

Councilman Branca states we have a vacancy on the ARB. Mayor Kapp says we have names of two or three people who would like to be on the Board.

Councilwoman Leonard moved to appoint Carol Cybulski to the ARB, second by Councilwoman Scarbrough. Term expires December 9, 1999. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

State Law - relevant portions of 18.2 and 46.2 by reference - Councilwoman Scarbrough moved to approve, second by Councilman Branca. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

Certificate of Insurance for Building Official - Mr. Lowery says his stuff is in the hands of his attorney. He states his contractors to him are contractors under him and do not require liability insurance.

Bicentennial - Councilwoman Leonard is working on a cancellation stamp, hats and shirts, etc.

Banner - haven't discussed yet.

ISTEA Grant - Atty Jamison says virtually all title work is done. Sid says would anyone be interested in getting a title for the Town Hall. He said the Town Hall was given by Skinker in 1799.

Atty Jamison states the easements will be ready in 15 days.

Madison Street improvements - Charles Smith Fence. Councilwoman Leonard asks if anything can be done with the Madison Street cul de sac improvements. Lois to have those easements done within 15 days. VDOT will do the paving next year.

ISTEA easements - Utility Easements, Joe Contrucci has them.

Railroad - nothing new.

Landscape Ordinance - Mrs. Turner asks if Council is going to soften the enforcement. Councilman Seffinga states if there is no enforcement what is the use of an ordinance. Atty Jamison states a Class 4 misdemeanor is punishable by up to \$250 in fine, Class 3 up to \$500, class 2 and 1 jail time starts plus money. Atty Jamison states all violations are criminal misdemeanors. Councilman Branca moved to approve the Landscape Ordinance, second by Vice Mayor Shepard. Councilman Seffinga asks if the Article # needs to be filled in. Atty Jamison states to fill in Chapter 12. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

Internet/Website - Mayor Kapp will work with a new volunteer.

Town Hall - Mayor Kapp states before we move in he would like to (1) get decent seats - do not want to take benches back in, Mayor Kapp will check into cushioned folding chairs - Council was informed by Mr. Lowery the code rating was no more than 49 people at one time, (2) Mayor Kapp has a bid of \$2300 and \$800 for a door. He talked to Ms. Swisher and will call Winchester Wood Working, (3) check with phone company to move phones.

Jeannie's Requests - Councilwoman Leonard asked if we should move on these. Tabled.

Kruse Corner - VDOT working on it.

Payne Property gutter - VDOT working on it.

Rats - tabled.

Trash - Councilman Seffinga asks if we don't go on the County plan what will residents do with stuff the town trash hauler won't take? Mayor Kapp will have Tom Smith of Solid Waste office come back in July.

Greenhill Crossing Fence - ARB to look at.

Inspection of Commercial Property - occupancy permit. Atty Jamison states he looked into it and found it is only if the use changes. Councilman Seffinga *wants to be sure we comply with* state law. Town Clerk states Gary Eddy had her send him all business license change of use. Mr. Lowery says April 15 state law requires all residential single family rental or leases property requires an inspection. Mr. Lowery to give Atty Jamison the code reference.

Cramer's Hauling - letter from owner stating no employees. Councilwoman Leonard moved to approve, second by Councilwoman Scarbrough. Yeas: Shepard, Scarbrough, Leonard, Seffinga. Nays: None. Motion carried by 4/0 vote. (Councilman Branca left.)

Councilwoman Leonard asked if we can send a letter, she has gotten compliments the yard looks nice.

Lane's - Councilwoman Leonard moved to approve business license, second by Councilman

Seffinga. Councilman Seffinga asked Mr. Lowery about fire report. Virginia Power is not the problem. The problem is Mrs. Lane and money. When she activates the 400 amp service her existing wire will not hold it.

Fire extinguisher is not required by code. Mr. Lowery states under property management we have authority not to approve the license.

Councilwoman Leonard states she talked to someone who said Larry Terry will move here when they close the garage (in Gainesville). Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

Gas Company franchise - Atty Jamison states it is in form to advertise. Must be in paper four weeks. He got commonwealth franchise from 1980, City of Manassas, the ordinance we received is different and most favorable to them. Maybe we could get a \$10,000 bond and odorize the gas and get more concessions. We should reduce the term to twenty years. We will only get one bidder, Columbia, because they physically have their lines there. Atty Jamison states it is to our advantage to get a shorter term.

Councilman Branca says with the franchise we are giving them the right to install the lines.

Franchise Fee - Atty Jamison doesn't know what we will be able to receive. City of Manassas was getting a fee. He thinks the utility tax fees is all we can expect. The other companies who now offer gas will receive our utility service ordinance. This is a talking point with the gas company.

Virginia Power - rates recommendations. Mayor Kapp gave to Atty Jamison for June meeting.

New Electric Service - Councilman Branca asked if we have an ordinance for all new service be placed under ground. Councilman Branca says they put a new pole in Section 9 of Greenhill. He suggests we put it in the ordinance all new service be underground.

Painting of roof and shutters of Town Hall building - ARB to look at colors.

Storm Drain on Washington Street - Mayor Kapp to call Mr. Gray, VDOT

Sheetz Violation - ARB to pursue

Costello, Century Stair - comment from Health Dept. Pump and haul system, if they agree that is something the town will have to have bonded, contractual arrangement, the town and Va. Health Dept and licensed sewage hauling company. Councilman Branca states it appears Mr. Contrucci's letter they would consider pump and haul. Councilman Seffinga asks why they don't want to connect to public sewer. Councilwoman Leonard asks if residents were forced to connect why aren't they required. Councilman Seffinga says as a town we shouldn't allow a pump and haul system. Councilman Branca says he has not seen the two pieces of correspondence. Councilman Seffinga says if they want to develop that property they should connect to sewer. He thinks the town should tell Mr. Costello the town is not offering a pump and haul system. Mr. Lowery asks if Sheetz is on septic. Councilman Branca says no. Mr. Lowery wants to know why

the septic tank is pumping out at this site. Councilman Branca says Sheetz is pumping to the sewer across the road. Mr. Lowery says the septic tank drives says he's there twice a week. Mr. Lowery says there is a grease trap system that works only on a sewer system.

Winterham - demouse the office. Mayor Kapp will talk to Mr. Costello.

Franchise, telecommunication - The Town Clerk asked what license and permits are required for telecommunication companies. Councilman Branca asked about the conduit on the outside of the tower. Bell Atlantic is in the rear. Councilman Branca states all conduit and wiring was to be inside the tower. Councilman Seffinga moved to require accounting to all cell phone service in the Town of Haymarket, second by Vice Mayor Shepard. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

Atty Jamison states telecommunications will be subject to BPOL, gross receipts and consumer utility service tax in town.

Mr. Lowery asks if the minutes will show all the wiring would be inside the tower? Yes. Council asked Mr. Lowery not final until ARB checks. ARB to research.

Longstreet Commons - Townhouses will be paving and marking the streets. Mayor Kapp suggests we give them slack on parking during this time.

Mountain View Elementary - a thank you for the ad in the yearbook was received.

Campaign contribution - Mayor Kapp states he received a \$250 campaign contribution. He did not have any expenses. He requested the donor add \$50 and buy a park bench for the street improvement.

Business License violation (Bailey) - Atty Jamison reports to limit fee to business license, there is no exemption allowed by the state code.

Prince William Municipal League, May 28, Manassas Regional Airport, all invited.

Franchise Tax - nothing needed.

Town Clerk request for back pay for meeting hours - Councilman Seffinga moved to approve, second by Councilwoman Leonard. Yeas: Shepard, Scarbrough, Leonard, Seffinga, Branca. Nays: None. Motion carried by 5/0 vote.

Old Bank Cafe and St. Paul's parking lots proposed - Mr. Lowery asked if we will give a site development permit. He wants to know who will inspect. Councilman Branca states BDE has done that in the past. Site development permit will be required. Councilman Branca will look at the process.

Councilwoman Leonard states she understands the street scape requires all buildings are to be on

the street. The Old Bank Cafe has to build a break wall. Councilman Branca says it was a proffer.

Councilwoman Leonard wants all boards to be sound and firm that if someone buys a property without checking feasibility and expects to be able to build, that is their problem. She states further that a builder told her he would want the ARB to require him to build brick, stone or stucco instead of frame.

Councilman Branca will talk to Mr. Lowery about site development permit.

Town Hall, forsythia trimming - from the Town Hall to the caboose, cut down to 3 to 4', clean up \$500. Ten yards of mulch, edge grass. Sherry Aits, Metropolitan Plants.



**AN ORDINANCE TO AMEND AND REENACT THE CODE OF ORDINANCES,  
TOWN OF HAYMARKET, VIRGINIA (1989), AS AMENDED, BY REENACTING  
SECTION 8-4, TO INCORPORATION BY REFERENCE CERTAIN PROVISIONS  
OF TITLE 18.2 RELATING TO DRIVING WHILE INTOXICATED  
AND CERTAIN PROVISIONS OF TITLE 46.2  
RELATING TO MOTOR VEHICLE OFFENSES**

BE IT ORDAINED by the Council of the Town of Haymarket, Virginia, meeting in Regular session this 11<sup>th</sup> day of May, 1998, that:

1. That Section 8-4 of the Code of Ordinances of the Town of Haymarket, Virginia (1989), as amended, is hereby reenacted as follows to incorporate statutory changes effective July 1, 1997 and any later changes:

**Section 8-4. Adoption of state law**

(a) Pursuant to the provisions of Code of Virginia, Section 46.2-1313, all applicable provisions of the following sections of Title 46.2, of the Code of Virginia (1950), as amended, are included in this section by reference:

Title 46.2	Chapter 1	46.2-100 through 46.2-113, all inclusive
	Chapter 3	Articles 1 through 15, all inclusive
	Chapter 6	in its entirety
	Chapter 8	in its entirety
	Chapter 10	in its entirety
	Chapter 12	in its entirety
	Chapter 13	in its entirety

As provided in Virginia Code Section 1-13.39:2, this ordinance includes future amendments to the statutes cited above.


(b) Article 2 of Chapter 7 of Title 18.2 of the Code of Virginia (1950) as amended, as in effect on July 1, 1997, is hereby adopted, mutatis mutandis, and incorporated herein by reference pursuant to the authority contained in Section 46.2-1313, of the Code of Virginia.

(c) Crimes or offenses committed within the Town of Haymarket, which are misdemeanors under this Section 8-9 may be charged as "violation of Section 8-9, Code of Haymarket, incorporating Section 18.2-\_\_\_ or Section 46.2 - \_\_\_\_\_, Code of Virginia" or words of similar import.


