Meeting called to order at 7:04pm.

Supervisor Stirrup was present. Will try to come to a Council meeting once a quarter to speak. He mentioned there will be a Board meeting Tuesday (August 7, 2007) with two (2) Public Hearings. One on consideration of restriction of trucks on Fayette Street that he believes will move positively, and the other on a restriction of watercraft, trailers, etc. on on-street parking (Greenhill Crossing, Gap Way, McGillis Road, Red Horse, and Susquehanna Road). He gave not that Heathcote Boulevard is now open, and other road projects will be completed in the next 2 ½ years (i.e. Old Carolina Road being widened, Piedmont Vista to Route 66.

Questions from Citizens for Supervisor Stirrup:

Maria Turner: Why is Old Carolina Road widening to Route 66? Will there be an asphalt sidewalk?

Supervisor Stirrups response: There will be an 8-10' asphalt trail. The bridge will be widened to four (4) lanes in the future, and a pedestrian crossing will possibly be added.

Maria Turner: Will there be a No Thru-Truck sign at Old Carolina Road? Supervisor Stirrups says there's an alternative route that is proposed using Washington Street

to James Madison Highway, to Haymarket Drive to Old Carolina Road.

Brian Knepper, from Dominion Construction, asks about Route 66. Supervisor Stirrup says there will be a widening of Route 66 to Route 29 (Exit 43) and off-ramps.

It looks to be about a 44 month project, and he believes they are ahead of schedule on the project.

Councilwoman Sikorsky enters the meeting at 7:05pm. Councilman Vazquez and Councilwoman Shuryn enter the meeting at 7:07pm.

Citizens Time:

Chuck Carnahan - Hunting Path Road

He had sent an email to the Town Council, regarding the 4,000 square foot lot size for Home Businesses (he refers to Zoning Ordinance 58 16 (8). He feels it's a disservice to the community by limiting the availability for a Home Business. It seems to be a Blanket Statement eliminating any home business (Tupperware, Home Chef, etc.) He asks that the Planning Commission and the Town Council review this, and hopes it was just an oversight in the Code and not intentional.

Vice Mayor Cole asks for the average lot size. The average lot size is 1800 – 3200 square feet. That means one (1) lot allowed per 110 homes.

Mayor Stutz says this is not an oversight, and can assure that no one is singled out. The Planning Commission will review this code.

Rebecca Bare - Cheyenne Way

President of Long Street Commons Homeowners Association. She feels the minimum square footage should be based on the type of business. Not just a broad spectrum.
