- a) Commercial vehicles shall not be parked on lawns or the public right of way;
- Commercial vehicle parking shall be limited to two vehicles parked within the existing garage and/or asphalt driveway or one commercial vehicle and one empty trailer parked within the existing garage and/or asphalt driveway;
- c) Maintenance of commercial vehicles and/or equipment shall be contained within the existing garage;
- d) Outside storage of landscaping materials or heavy equipment shall not be permitted;
- e) No employee parking shall be permitted.

I further move that the SUP shall remain in effect for a period of one year, to renew automatically for additional periods of one year, BUT EXPRESSLY CONDITIONED UPON THE FOLLOWING: Council may require, upon a majority vote, after notice to the applicant, for the applicant (or present property owner) to submit a new application for an SUP, which shall be treated in all respects as a new and different application, subject to approval or disapproval, in accordance with general principles of law for a new application. If such notice is given to the applicant or present property owner, this SUP shall terminate automatically and without further notice or action by the Council 60 days from the giving of such notice.

• Hunter at Haymarket is a PWC application to develop 11+ acres of land at the Town's southeast boundary line with the county. The Town has opposed this application for rezoning and a comprehensive plan amendment. It was denied at the last PWC Planning Commission meeting. It is going before the Board of County Supervisors scheduled for October 18 and could be decided at that time. Weir asks the Town Attorney if the town has standing, should the BOCS approve, to appeal to the County Board of Zoning Appeals? Taxpayers are typically not considered an aggrieved party. The Town is to review any division of land; he feels the town would have standing to file an appeal. The Town Attorney reminds that we sent a letter saying any approval would be void without the Town's prior approval. The Mayor suggests that the Town write a follow-up letter. **The Town Attorney and Councilman Weir to write the letter.
