Ring: A developer has brought in a plan that they are considering on the Payne Lane property. Major concern would be parking & Signage. RFP for parking is on our agenda tonight. Is signage a part of it? No it is not.

Weir needs an update on rebuilding the bridge on Old Carolina. Will they shut the whole bridge down? Marchants assumption too. Not aware of any change. But they are now going to flip it. Close Catharpin and keep Old Carolina open. Build new Catharpin. Last official word we have is shut Catharpin down.

Regardless will have impact on parking. Get some clarification on that from Holly.

Council Update: Bare informs that the Old Post Office is receiving an award for it's appearance from the Community Appearance Alliance of Northern Virginia.

## 7. Town Planner Report

Sheetz, submitting next week.

Approved Preliminary Site Plan for Ice Plex expansion. They have halted.

Fire house has a new ownership. Not heard from them since the purchase.

Payne Lane development possible. PC would like to see copies of the plan.

Several interests in the Winterham mansion.

Went into QBE's new place at the old PACE West. They are about done with renovations. Take a look if you get a chance.

Received a one mile notice for rezoning for Midwood. Active Adult community.

Bare asks about McDonalds? Waiting to hear from the Attorneys. They will say they're ready to submit, then disappear again. They are more interested in dual turn lanes than refacing. Some language about the access/turn lane, that if the Town complained about the traffic, that the owner of the property, Mr. Leaberry, could step in and close it. Would have to be a formal complaint from the Town.

Chick-fil-A is looking at the vacant pad site at Quarles. Dual turn lane. Wrap around the back of the building. We have commented.

With interchange improvements that first entrance, would be a median.

On Jordan Lane, the old garage. They have put in for Demolishing it.

Bare asks about Robinsons Paradise? They asked for meeting with us. We provided comment. We base our proffer fees off CIP. Currently tied with county's proffers. Currently under review. Or we mirror them? They're redoing theirs. Weir to get with Candland where they stand on that.

Self Storage site plan still under review for outdoor storage.

Enclosed rear structure where Next Level Fitness is.

New waterworks company in Rose building. Outdoor storage of plumbing materials.

Bus lot. Zoned C1. He knows that. Why does this keep coming up? Can't have anything in the flood plane no matter what.

Staff review of self storage? Month after next. SUP.
