Water Supply Plan

Mr. Normand Goulet with the Northern Virginia Regional Commission is here this evening to present the Regional Water Supply Plan to the Town Council. He explains to Council that the water supply plan was an unfunded mandate passed on to the localities by the General Assembly. Some was due to lack of planning; some was due to drought conditions. This was more of an assessment and inventory of existing sources. Some of the purposes were to: Assess existing uses; Drought response and demand management.

Weir asks about the numbers in the out years, is that based on future developments also? Yes it does look at anticipated growth. Weir asks about an ordinance, is there a draft ordinance. Yes there is, but he does not believe we will need one since we do not own and operate water supplies. He should know for sure very soon. **Weir asks him to forward the model.
