HAYMARKET TOWN COUNCIL MEETING: OCTOBER 15,1990

All members of Council were present at the Oct. 15,1990 Haymarket Town Council meeting when it began at 7;30 p.m., led in a Prayer and Pledge of Allegiance by Acting Mayor, John Kapp. James Shepard made a motion to accept the minutes of the previous meeting, not to be read & they stand approved with one exception, Officer Joseph Gerace's tuition of \$400. to the Rappahannock Regional Criminal Justice Service be deleted, this was seconded by Ronald Hancock, the motion carried unanimously. The Treasurer reported a balance of \$62,521.53 in the General Account at the end of Sept. 1990. She also reported a bill to be paid;

1. Embassy Autowash, Washing Police Cruiser \$18.75

Bean made a motion to pay the bill, seconded by Hancock, the motion carried unanimously in a Roll Call Vote.

COMPREHENSIVE PLAN:

Kapp reported that the Comprehensive Plan had gone back to the Haymarket Planning Commission, they took no action on it but had sent it back to Council. Dottie Leonard made a motion to hold a Public Hearing on the Transportation Section of the Jomprehensive Plan on Monday, Nov. 19,1990, at 7 p.m., seconded by Shepard, the motion carried. It was to be advertised two times in the Journal Messenger.

ALAN GOSSOM'S SITE PLAN:

It was announced that Gossom and Fred Price would get together to work on Gossom's Site Plan.

PUBLIC HEARING:

Kapp announced that he would be goin to the Public Hearing on Oct. 24,1990 regarding the plan Jack Clark spoke about at a recent meeting and he would recommend the Diamond Urban Plan. Attorney Steven Woodside said he will write a letter from the Business Association to take to the meeting. Other interested parties said they would like to go too, everyone was to meet at Town Hall on Oct. 24,6;15 p.m.

Water from the Hairmarket Parking lot is running on Fayette St., according to Fred Price, Kapp and Alan Gossom will take a look at the situation on Friday.

COSTELLO'S BOND: CENTURY STAIRS.

Steven Woodside said that Don Costello wants his Bond to the Town reduced to Fifteen Thousand instead of Sixty One Thousand. Attorney Woodside was told to have it put in writing, then to have someone review it like our Building Inspector or Costello's Engineer.

PIGS IN TOWN:

Lonnie Whitlow asked what the Town Ordinance: was on pet pigs in Town and Kapp said they weren't allowed.

WASTE MANAGEMENT:

Leonard made a motion to send a Resolution to Prince Tilliam Co. for their Waste Management Plan(Copy enclosed in minutes), this was seconded by Hancock, the motion carried.

OTHER ITEMS:

Steven Bean mentioned he had a couple of calls in regards to the Adult Home on Madison St. A gentleman in a wheelchair was outside after dark and almost got hit by a vehicle. Officer Damron will explain the situation to Mrs Virginia Malls.

Bean also asked since Council had decided to leave Terri Freeborn's name on ballet, if the Town could pay for part of her legal fees? He was advised this would not be possible.
