# HAYMARKET TOWN COUNCIL MEETING APRIL 16,1990

All Council Members were present at the April 16,1990, Haymarket Town Council Meeting with the exception of James R. Gossom who is still in the hospital. The Mayor began the meeting at 7;30 p.m. with a Prayer

Kapp made a motion not to read the minuets of the previous meeting and Pledge of Allegiance. but wanted to make one correction. In regards to the light to be placed on Madison St. between Mr. Bear and Mr. Hunt's property, Mr. Hunt does not want the light, so the location will be changed, the motion was seconded by Bird, the motion carried unanimously. It was decided that Kapp will check with the party on the other side of Glenwood Bear about placing the in the general light there.

The Treasurer reported a balance of \$76,868.23 account at the end of March, 1990. She also requested that the following \$99.89 bills be paid;

2, - EMBASSY AUTOWASH, WASHING POLICE CRUISER Kapp made a motion to pay the bills, seconded by Hancock ,approved unanimously in a Roll Call Vote.

Sequoia Building Corp. asked that the Bond for \$5,000.00 for the BONDS: Siltation & Erosion Bond and also the \$16,000.00 plus interest for the grading at Longstreet Commons be released. John Berger had alread approved the work that was to be done. Bird made a motion to release both Bonds, seconded by Kapp, approved unanimously in a Roll Call Vote.

Glenwood Bear & green that a copy of the Town's Charter be hung on CITIZEN'S TIME: the wall in lown Hall. He was informed that it was too long and there was not room to hang it up on the wall.

Mr. Bear felt that since it is getting close to Election Time, all names of those running should be posted in Town Hall. He also congratulated Layor Terri R. Freeborn for the job she has done as Mayor.

BUSINESS LICENSES:

Bird made a motion to approve a Business License for James Gossom, Trading as B.B.C.S., Nature of Business is Advertising by Mail. This was for a change of address only, they are moving from Office #1 to Office #6, at 15000 Washington St. This was seconded by Bean, the motion carried unanimously.

BUILDING PERMITS:

A Building Permit submitted by Alan Gossom to replace a plywood roof at 15001 was turned over to the Planning Commission for their recommendations.

SIGN PERMIT:

Bean made a motion to approve a Sign Permit forDr. Albert J. Weaver, 6611 Jefferson St., this was seconded by Kapp, the motion carried unanimousl It had already been approved by the Haymarket Planning Commission. PLANNING COMMISSION:

The Planning Commission recommended approval of a Building Permit for William Hunt, 6751 MADISON ST. TO REPLACE a Chimney. Bird made a motion to approve it, seconded by Kapp (It was mentioned that it had to be built

by the Kabo Standard), the motion carried unanimously.

The Planning Commission also recommended approval for demolition of an interior retail wall to increase retail floor space at 15015 Washington St., trading as Haymarket Grocery. Hancock made a motion to approve it, seconded by Crouch, the motion carried unanimously.

After the Planning Commission made a recommendation to approve the 3 tiers or steps for Michael Goettlemann at Katie's Country Crafts to be placed under his window to place flowers on, Bird made a motion to approve it with stipulations made by the Planning Commission (A copy of the Resolution is enclosed in these minuets)., this was seconded by Kapp, the motion carried unanimously. Councilman Steve Bean also made a motion not to charge a fee for this, seconded by Bird, the motion carried uaanimously.

The Planning Commission recommended denial for a Sign Application for lown and Country Auto at 15161 Washington St., as it is considered to be a violation of Town Code , section 8-3-6, NoTracethan one freestanding sign on a parcel. Fird made a motion to deny the Sign Application and give Fown and Country Auto 30 days to take the sign down or go to the Board of Zoning Appeals, this was seconded by Hancock, the motion carried wif 3 Council Rembers voting to deny it and Councilman Sam Crouch voted in favor of letting him put up the sign.

THANKED: Mayor Terri R. Freeborn thanked the Picture Patch for the picture of Town Hall they presented to the Town that was hung in Town Hall.
