HAYMARKET TOWN COUNCIL MEETING

SEPTEMBER 17, 1990

All members of Council were present at the Sept. 17, 1990, Haymarket Town Council Meeting with the exception of Steven Bean who was ill. Attorney James Davenport was present for Attorney Turner T. Smith. Acting Mayor John Kapp presided over the meeting which began at 7:30 p.m. with a Prayer and Pledge of Allegiance.

Councilman Ronald Hancock made a motion to dispense with the minutes of the previous meeting being read and that they stand approved, this was seconded by Councilman James Shepard, the motion carried unanimously. The Treasurer reported a balance of \$70,619.10 in the General Account at the end of August, 1990. She also reported the following unpaid bills;

Hancock made a motion to pay the bills, seconded by Shepard, the motion carried unanimously in a Roll Call Vote.

CITIZEN'S TIME:

No one spoke in Citizen's Time.

SIGN APPLICATIONS:

Councilman Sam Crouch made a motion to approve a Sign for The Autobaun Motors, 6707 Jefferson St., seconded by Shepard, the motion carried, having been approved previously by the Haymarket Planning Commission.

BUSINESS LICENSES:

Upon recommendations from the Planning Commission, a Special Use Permit for the Autobaun Motors was approved, Hancock made the motion on this, seconded by Crouch, the motion carried unanimously.

BUILDING PERMITS:

Upon approval from Building Inspector, Gary Eddy, Hancock made a motion to grant a Building Permit for Quarles Petroleum T/A Q Stop Food Stores to move sales counter area, add 10 electrical circuits, this was seconded by Crouch, the motion carried.

Also upon Gary Eddy's approval, Hancock made a motion to approve the demolition of the Barbecue Pit, a 14X16 Building, this was seconded by Shepard, the motion carried.

REPORTS:

The morning of Haymarket Day, Sept. 15, 1990, a group of Councilman and others walked around Town with Gainesville Supervisor, Bob Cole looking at drains, it has now been decided to have VDOT come in and walk around Town.

Action on sidewalks in Town will be delayed until drains are fixed. Sidewalks are to be cleaned, patched and concrete is to be considered for new sidewalks.

POLICE DEPT:

Officer Joseph Gerace gave a report on purchasing bullet proof vests. There is a Federal Standard one that weighs three pounds and the price is \$350.00, for \$20.00 more a piece can be purchased that if the shirt is unbuttoned, it can be slipped in to protect against rifle firing. These if purchased can be shipped within 4 weeks. Leonard made a motion to purchase both the vests and pieces to go in them, seconded by Hancock, the motion carried unanimously in a Roll Call Vote.

BULLETIN BOARD:

Acting Mayor Kapp announced that there would be a delay in obtaining the Bulletin Board from the Ruritans. They found that the one they were going to donate to the Town would be too expensive and the Ruritans will build it themselves. Discussion of changing the location at Town Hall where the Bulletin Board was to be placed was discussed. Officer Gerace mentioned it should be placed back from near the road so that no one would be driving along Rt.55 and have an accident trying to read it.

LYSSA WHITFIELD:

Hancock mentioned that last week he made a motion not to pay to send Lyssa Whitfield to the Conference she wanted to attend but after talking to Fred Price, Chairman of the Haymarket Planning Commission, who thought it was necessary to send her, he wanted to make a new motion, Hancock made the motion to send Lyssa Whitfield to the Training Conference and pay for it, including her hotel room, this was seconded by Shepard, the motion carried in a Roll Call Vote, 4 Councilman voted in favor of this, Sam Crouch voted against it.

REPORT ON DANCE:

Councilman James Shepard gave a report on the dance held on Haymarket Day. It started out slow, only \$93. was made at the gate. He paid the first Band \$18.60 and sent them home early, the seconded Band was a lot better and they charged \$450.00. Leonard made a motion to reimburse James Shepard for \$367.00 he paid towards the second Band, this was seconded by Crouch, the motion carried in a Roll Call Vote, 4 Councilman voted for it and Councilman James Shepard abstained from voting.

OTHER ITEMS OF BUSINESS:

Glenwood Bear said he would like to welcome Town Attorney James Davanport.

Councilwoman Dottie Leonard remarked how interesting it is that Council does so much of what Mr. Bear suggests and thanked him.
