HAYMARKET TOWN COUNCIL MEETING DECEMBER 17,1990

The December 17,1990. Haymarket Town Council Meeting began at 7;30 p.m. All members of Council were present, also Attorney Turner T. Smith. Acting Mayor John Kapp led in the Prayer and Pledge of Allegiance. Ronald Hancock made a motion to dispense with the reading of the minutes of the previous meeting and that they stand approved. One correction was made, Mr. Bear said he would like to have sidewalks on Madison St. by Next Christmas, instead of a new sign as stated in the minutes, this was seconded by Bean, the motion carried.

The Treasurer in a revised Treasurer's Report reported a balance in the General Account at the end of November of \$66,305.63. She also reported the following bills to be paid;

REGIONAL SHOPPING MALL:

The proposed Shopping Mall to go in near Rt.15 on the Morgan or also referred to as the old Wesinberger Farm was discussed briefly. POLICE REPORT

Officer Damron reported that more Code Books are needed by the Judicial System. Miss Keech will check to see how many will be needed. He reported the Cruiser needs new tires, cost to be about \$267.96. He has aquired another gun and needs two boxes of shells, cost of which is to be \$17.98. The Cruiser is in the Haymarket Service Center having work done on it. Leonard made a motion to approve everything Officer Damron wants as it all sounds necessary, this was seconded by Hancock, approved unanimously in a Roll Call Vote.

TREES:

Mr. Bear reported that he has requested 100 trees. The Town has to decide what type of trees they want. Mr. Kapp asked Mr. Bear if he could check with homeowners in regards to the trees. Hancock reported he has spoken to Mr. Milhous and he was going to give him a list of trees with in a week. Hancock went on to say in the letter from the Dept. of Forestry in which he checked into, it is a grant and it is only a short period of time it is open, we have to give them a proposal.

CTTIZEN'S TIME:

Glenwood Bear said he was glad to see people in Haymarket taking more interest in decorating their houses for the Christmas Holidays.

Bobby McManus spoke saying she was the one that was taking up the petitions for Terri Freeborn in Town because she liked Terri and at the same time she also got a list of registered voters. It was not Annie Snyder or Tony Guiffre as had been rumored.

Councilman James Shepard said he had checked into the Fire Insurance on Town Hall. It was undecided as to whether to raise the insurance or not.
