HAYMARKET TOWN COUNCIL MEETING: MARCH 18,1991

All Council Members were present at the March 18,1991 Haymarket Town Council Meeting when it began at 7;30 p.m. with a Prayer and Pledge of Allegiance.

Mayor John Kapp welcomed David DeCarlo as the newly appointed Council Member.

Hancock made a motion to dispense with the reading of minutes of previ-Ous meeting and that they stand approved with several minor corrections, this was seconded by Bean, the motion carried.

The Treasurer reported a balance in the General Account of \$84,007.21 at the end of February, 1991. She also reported the following unpaid bills, they were;

GUESTS:

We had three guests at the meeting. Mayor Kapp introduced Tu Young, the wife of Mark Lehtimaki who is in Kwait. Council decided to dispense with the cost of Mark's Town Tag, the motion was made by Leonard, seconded by Shepard and unanimously approved in a Roll Call Vote.

The next Guest Speaker was Dan Liston from VDOT who spoke on their work and plans for the future and received and answered a lot of questions at the end of it.

Diana Dutton from the Prince William Co. Soil and Erosion spoke on Arbor Day. She said she has been working with Friendswood who wants to be good neighbors with the Town of Haymarket and donate a couple of trees to be planted in Town. She mentioned that the Town should have a Ceremony for this in which Friendswood would like to take part in. Dutton offered to wo with Glenwood Bear, Mark Branca and that group who are working on trees in Town. She is also going to send a Proclamation to be signed. The date of the ceremony will be decided at the April 1,1991 meeting.

SIDEWALKS:

In regards to replacing broken concrete on the sidewalks on Jefferson and also Fayette St., it was decided that there would be a Walk Thru on March 23, at 3 p.m. to look things over. A Committee composed of Mayor Kapp, Mark Branca, Ronald Hancock, James Shepard and Fred Price will take part in this. They will carry a can of Spray Paint for Marking. Results of this to be discussed at the next Council Meeting.

Mr. Smith said that the new Council Table that is being considered doesn't have to be put out for bids. Leonard said Council should consider the two plans and prices presented by Lonnie Whitlow and Mark Branca.

Mayor Kap mentioned that the President has asked everyone to do something for the 4th of July. Hancock suggested putting up flags and to redo the yellow ribbons. The Town will purchase some flags. Leonard suggested putting in the Newsletter to encourage people in Town to

OTHER ITEMS OF BUSINESS:

Council Bean said he had the storm window that goes in Town Hall and would put it in on Turesday, March 19.

The Mayor gave out copies of the Budget thru the Month of January and told Council to look it over as they would be working on the new Budget soon.

Since there is a vacancy on the Planning Commission since David DeCarlo has been appointed to the Town Council, Leonard brought up the name of Sarah Turner again. Several other names were also brought up. Councilman Bean said he would like not to appoint anyone to the Planning Commission until the new Budget comes in, this was seconded by Crouch, in a Roll Call Vote, 5 Councilmen were in favor of waiting, David DeCarlo voted no.

New Name Plates were discussed for Kapp, Crouch, and DeCarlo. Bean made a motion to purchase the new ones, seconded by Hancock, in a Roll Call Vote, 4 Council Members voted to purchase them with Crouch and DeCarlo abstaining, the motion carried.

CITIZEN'S TIME:

Mr. Bear congratulated the new Council Member, David DeCarlo, and the new Vice Mayor, Sam Crouch.

He mentioned that he would like the Town Council to consider story telling at least 2 times a year.

Attorney Steven Woodside mentioned that he had spoken to Rick Smith about getting funding for the Town, to write to him, his address is 1 County Complex Court, Prince William, Va. 22192. Shepard would like to see him come to 1 of the Council Meetings to discuss funding..

HISTORIC COMMISSION:

Leonard made a motion to appoint Sarah Turner to head the Historic Commission saying she thought she would be good. She could also appoint people in Town to be on the Committee, this was seconded by DeCarlo, the motion carried.
