HAYMARKET TOWN COUNCIL MEETING-APRIL1, 1991.

Four members made up the quorum at the April 1,1991 Haymarket Town Council Meeting, Councilman Steven Bean and Councilman David DeCarlo were absent. The meeting began at 7;30 p.m. with Mayor John Kapp leading the Prayer and Pledge of Allegiance.

Councilman Ronald Hancock made a motion that the minutes of the previous meeting be approved with several corrections and that it be dispensed with the reading of them, this was seconded by Councilman James Shepard, the motion carried.

The Treasurer reported several bills to be paid; they were;

1. MOBILE, GAS, POLICE CRUISER

2. TEXACO REFINING & MARKETING, GAS, POLICE CRUISER \$106.06 Councilman Sam Crouch made a motion to pay the bills, seconded by Councilwoman Leonard they were unanimously approved in a Roll Call Vote.

SIGN PERMITS:

Councilwoman Dottie Leonard made a motion to send 2 Sign Permit Applications to the Planning Commission, one for Haymarket Pre-School and the other was for Atlantic Auto to be sent back to Planning for the second time since the new Sign Ordinance which this would come under came into effect on April 1,1991, this was seconded by Shepard, the motion carried.

BUILDING PERMITS:

Leonard made a motion to send the Building Permit for Richard Glass to the Planning Commission. Since Mr. Glass had not submitted any plans, he was to be notified to turn them in by the next night to the Planning Commission, this was seconded by Shepard, the motion carried.

Leonard made a motion to send a Building Permit application for Brian Drummond, 14815 Rising Sun Lane to build a detached back yard deck, to the Planning Commission saying it would be approved if it meets requirements and Building Official Gary Eddy approves it, seconded by Shepard, the motion carried. SPECIAL USE PERMITS:

Hancock made a motion to approve 2 Special Use Permits for Wolfe Auctions and Underwood's Concessions. Wolfe would like to hold an Auction on Friday, May 3, 1991and Underwood's Concessions would like

TO SELL FOOD ON May 2 & 3,1991. Hancock also added a stipulation that everything be removed withing 10 days after the sale, this was seconded by Shepard, the motion carried unanimoulsy.

Gainesville District Supervisor Robert Cole was Guest Speaker at the meeting. He gave an interesting and enlighting talk, answering a lot of questions at the end. FIRE DEPT.

Mayor Kapp tabled this until all the Council Members could be present.

CONTEL FRANCHISE:

Regarding the Contel Franchise, Mr. Smith said there were several items he wanted to check with Contel on, he will be meeting with them on April 2 and will get back to Council after that.

Contel Representatives will be at the 1st meeting in May. SEQUOIA PERFORMANCE BOND:

The Performance Bond for Sequoia expired on Feb. 19,1991. Leonard made a motion to release it as they had requested, if Site Inspector, John Berger says it's all right, this was seconded by Hancock, the motion carried.

RECYCLING:

Turner Smith said the papers on Recycling has been mislaid at his office, he will try to find them.

Three Igloos will be placed behind Dr. Weaver's Building and there will be a Ribbon Cutting Ceremony.

VDOT-6 YEAR PLAN:

A Work Session will be held on Thursday, May 11, 7 p.m. on the Vdot, 6 year plan and the new Budget.

SIDEWALKS:

A group walked down Jefferson and Fayette Streets and marked places with paint that need to be repaired or replaced.

Hancock made a motion to put the work on the sidewalks out for bids. It should be advertised 2 times in the Month of April. There will be a Walk Thru on May 4, at 1 p.m. and bids will have to be in by Saturday June 1,1991, then they will come back to Council on June 3,1991.
