HAYMARKET TOWN COUNCIL MEETING

JULY 1,1991

All members of the Town Council were present at the July 1,1991 Meeting when it began at 7;30 p.m., with the exception of Dottie Leonard. Mayor Kapp openend the meeting with a Prayer and Pledge of Allegiance.

Hancock made a motion to dispense with the reading of the minutes of the previous meetings and that they stand approved, seconded by Bean, the motion carried.

The Treasurer reported the following bills to be paid;

- 1- HUTTON & PAYNE, TREASURER BOND, KELLER----\$125.00
- 2- THE MITCHIE CO., LEGAL BOOKS-----\$191.10 Hancock made a motion to pay the bills, seconded by Bean, the motion carried unanimously in a Roll Call Vote.
 BUSINESS LICENSES:

Business License was approved for Kenneth Dent, Trading as S & K Seafood to sell crabs at the corner of 55 & 15, Rex Phare's property. It was approved pending that he fill out a Special Use Permit, charge to be \$100. Bean made the motion on this, seconded by Shepard.

Crouch made a motion to approve a Business License for Gerald P. Last, Trading as Custom Glass, nature of Business will be Auto Glass Shop and Office, to be located at 6625 Jefferson St., this was seconded by Bean, the motion carried.

Crouch made a motion to approve a Business License for Henry Gillespie, Jr. Trading as Henry Gillespie Drywall and the Nature of Business being Drywall , Hanging Party Walls, at 6794 Fayette St., a stipulation was made, no work to be done at home and he was to fill out a Gross Receipt Form, this was seconded by DeCarlo, the motion carried. SIGN PERMIT:

A Sign Permit for Gerald Last was forwarded to the Haymarket Planning Commission .

Another permit application for a deck for Lyssa Whitfield was forwarded to the Planning Commission. Bean made a motion to approve it subject to the Planning Commission and Building Official Gary Eddy's approval, Seconded by Hawcke the Motion Carried. FRANCHISE:

Hancock made a motion to accept the Franchise Ordinance and also the bid for the Franchise from Contel of Va. and to adopt them, term to be 40 years, this was seconded by Shepard, the motion carried.

GUEST SPEAKER

The Guest Speaker for the meeting was Kay Rheinhart from Contel of Va. TAX RATE:

Hancock made a motion to accept the Tax Rate for 1991 to stay at .14¢ per hundred for Real Estate and .60¢ per hundred for Personal Property, seconded by Crouch, the motion carried.

ANOTHER BUILDING PERMIT:

Another Building Permit for Virginia Nalls was sent to the Planning Commission . This was to enclose existing carport to make I room, I bath and hall at Madison St.

Mayor Kapp said he would need volunteers to put up the Flags on July 4, also he needed volunteers to put some brackets together. He received some volunteers.

CARR PROPERTIES:

The Mayor spoke on the meeting of the Board of Supervisors and Carr Properties and said it probally be years until it was up this end.

Nothing has been suggested about Carr's property in Town.

CHANNEL 66

Channel 66 asked for an extension of time. Nothing was done about it at the July 1 Meeting.

HISTORIC COMMITTEE:

Sarah Turner, Chairman of the Haymarket Historic Committee spoke about a design for a Flag for the Town. May hold a contest in regards to designing one. At the present time ten(10) people have signed up to be on the Committee. July 11 will be the Committee's next meeting, in Town Hall, at 7 p.m. Hopefully they will be able to hold meetings two times a month, at 7 p.m., in Town Hall. The Haymarket Woman's Club will take on Cabins for the Museum as a project. The Historic Committee would like to have something in the Parade on Haymarket Day.

POLICE REPORT:

In regards to Police patches being purchased to sell for \$1. above cost. Crouch didn't think they should be sold to individuals.

Hancock made a motion that patches be sold to Police Organizations only at \$1. above cost, this was seconded by Bean, the motion carried.

CITIZEN'S TIME:

Sarah Turner said she thinks it's nice of the Carr people to go along with the Town.

Lyssa Whitfield asked the date of Haymarket Day and was told it would be the 3rd Saturday in Sept.

Shepard said that \$3,000. should be ear marked for the basic price of a Computer and that the Town Council should pursue the purchase of the Computer.

Crouch reported that a tree is blocking the speed sign on 55.

Hancock and Officer Kiley will go back in 2 weeks to check on mowing in Town.

DeCarlo said he had contacted the Postmaster regarding the mialboxes in LongstrecTCommons as some of them look terrible and the Postmaster told him they would be taken care of this year. The Mayor will talk to the Postmaster, Ellen Wilson. Lyssa asked if when they are replaced if they could have a stand over them.
