Said that a Public Hearing was needed to be held by Council on the following;, the Sign Ordinance, TV and Radios; and Auto Retail Sales, Salvage. Kapp made a motion to hold the Public Hearing on May 7, at 7 p.m., this was seconded by Hancock, the motion carried. This was pending getting it out of the Planning Commission the next night. This was seconded by Bird, the motio carried.

Kapp asked if we can negotiate on Insurance or does it have to be put out for bids Orr Town Attorney will let him know. Also he mentioned getting the Flag at Town Hall up by Flag Day and wondered where to place it?

Hancock and Kapp had recently attended the Haymarket-Gainesville Business and Professional meeting and Kapp said they are going to try to set up ways of raising money to balance the new budget.
