HAYMARKET TOWN COUNCIL MEETING

MARCH 5,1990

The regular Haymarket Town Council meeting began immediatelly after the Public Hearing at 8;05 p.m., the Mayor leading in the Prayer and Pledge

of Allegiance. Sam Crouch was absent. Kapp made a motion not to read the minuets of the previous meeting

with one correction, the name of Mr. Whitlow(first name Lonnie and not Lottie.) this was seconded by Bird, the minuets stood approved.

The Treasurer reported the following bills to be paid; \$16.50 1. Embassy Autowash, washing Police Cruiser, 3 times \$35.37 2. Avis Lube, Lube job, etc on Police Cruiser \$ 3.19

3. Gossom's Hardware, items P.D. and T. H. Hancock made a motion to pay the bills , seconded by Bird, unanimously approved in a Roll Call Vote, the motion carried.

· Glenwood Bear asked about the light on Madison St. It is being worked CITIZEN'S TIME: on. Also when is everyone going to have their pictures taken(Mayor, Council, Attorney, etc.)? The Mayor told him as soon as everyone is present.

Steve Woodside introduced Bob Mayer as President of a newly formed Business and Professional Association, Dr. Albert Weaver, Vice-President and his self as Secretary-Treasurer . They would like to have someone from the Town Council meet with them the last Wednesday this month to discuss

Dr. Weaver asked if anything can be done to bring water into Haymarket? Gross Receipts. Lorene Payne said nothing until Prince William Co. does it, Richard Bird

said it's about a mile away now.

Glenwood Bear asked about residents having their mail deliverd to their homes. Mayor Freeborn will inquire about it and report back on it at the next meeting.

Kapp-made a motion to approve a Business License for Lawrence Ayers, BUSINESS LICENSE: a Denist, at 6611 Jefferson St. Dr. Weaver said it was undecided whether he would be in Suites A or D. This was seconded by Bird, the motion carried after being unanimously approved.

SIGN PERMITS: Two Sign Permits were sent to the Haymarket Planning Commission, one was for Bonnie & Clydes and the other one was for Katie's Country Crafts and Farm Toys.

LORENE PAYNE: Lorene Payne reported that the Planning Commission met in a Work Ses last Monday night on the Comprehensive Plan, they will hold a 2nd Work Section night. A draft will be in Town Hall by Friday, March 16th so that Council will have it by March 19th, their meeting date.

The Planning Commission will also hold a Public Hearing on March 20, 1990. They will hold a Work Session afterwards.

RICHARD BIRD:

Bird said that the plan the Sub-Committee worked on will now go to the Board of County Supervisors, then a meeting with the Town Council will be set up at one of the Schools.

At 8;45 p.m., Kapp made a motion under section 3.1-244, A-6 of the Code of Virginia to go into Executive Session to discuss Personnel Matters, this was seconded by Bean, the motion carried.
