Dear Town Council and Members of the Planning Commission:

Attached hereto is an application for a business license for the above named person and company as well as a site plan showing the location and parking spaces available for this

Gene Wells is a likeable and personable individual who has lived in this area all of his life. He has been involved in the truck repair business for the last 8 to 10 years. He would like to become a member of the Haymarket community by starting a commercial vehicle repair business in a vacant building on the site of the Century Stair Company.

His business will employ 3 to 6 persons during the first year of operation. The site plan shows 10 to 12 parking spaces for employees and customers and 2 larger parking spaces if needed for trucks. No truck repairs will be performed outside the building unless of a minor nature. No salvage operations will occur outside the building. All waste oil and other waste products will be packed directly into 55 gallon storage drums which will be picked up on a weekly basis by Hasco Company.

These drums are special fire and explosion proof containers provided by Hasco for this specific purpose.
