A Public Hearing of the Planning Commission of the Town of Haymarket, VA, was held this evening in the Council Chambers, commencing at 7:00 PM.

VIII. Old Business

1. Comp Plan

Town Planner Emily Kyriazi stated that she recently accepted the position of Town Manager. She stated that part of her acceptance was to create goals and objectives. She stated that one of her goals was to bring a completed draft of the Comprehensive Plan to the Planning Commission within the next six to eight months. She shared that she would be working on that

at a staff level and will bring some portion of the draft to the Planning Commission for their input and assistance. She stated that this item will be a running Old Business item for continued updates. She stated that she hopes to have the completed comp plan drafted, a public hearing held and the comp plan implemented by Fall of 2023.

IX. New Business

Town Planner Emily Kyriazi provided updates on the Lidl, Kiddie Academy and Taco Bell site plans located within the Crossroads Village Center, Robinson Village townhome subdivision, and Robinson Paradise subdivision.

X. ARB Updates

Commissioner Rob Hallet shared that the ARB has not had a meeting since their June meeting. Mrs. Kyriazi stated that the ARB will be having a September meeting as there are items on the agenda for September.

XI. Town Council Updates

Councilmember Weir provided the Town Council updates. Mr. Weir shared that the Town Council ended the fiscal year with a surplus and that they are considering a real estate tax refund using one half of the surplus. He stated that the other half of the surplus would be tied to a CIP project. Mr. Weir also shared that the Town is starting to receive proffers from the on going developments to be used for CIP projects. Councilman Weir also gave a brief updates on items within Prince William County.

Town Manager Emily Kyriazi also gave some dates on upcoming Town Events. She stated that the summer concert is scheduled for August 20th from 4-8 pm and the grand opening of Trouvaille Brewery. Lastly, Mrs. Kyriazi reminded the Planning Commission of the vacancy seat that still needs to be filled.

With no further business before the Planning Commission, Councilmember Weir moved to adjourn with a second by Commissioner Chrisman. The motion carried.
