RE: Haymarket Events for Calendar Year 2020

Mayor and Council,

Due to the current COVID-19 restrictions I have worked on a back-up plan for the upcoming 2020 events, please see several options below.

May 16th Community Picnic – CANCEL the May date and reschedule for September 12th or 19th. At the Spring Community Picnic the playground was going to be officially dedicated to Alex Green, who passed away from Childhood Cancer. The rescheduled date would align with the Childhood Cancer Awareness Month. This event would be smaller scale and be geared towards the dedication and bringing the community together in the park. I would look to bring in a local food truck and ice cream truck. This event will be determined based on the budget and available sponsorship funds.

August 22nd Haymarket Music Festival – This event would be our second annual music festival at the park. Based on last year's numbers the event is approximately \$8 - \$10k with all proceeds going to a charity organization. I am recommending we **CANCEL** this event for the 2020 calendar year due to funding shortfalls for our sponsorship funds. If funding comes in higher than expected this event could be rescheduled for June 2021, keeping it within the FY2021 budget year. If funding does not come in, I will proceed with an August 2021 date for the next Haymarket Music Festival.

October 17th Haymarket Day – I am recommending we proceed as planned to hold our annual Haymarket Day with some or all of the below options.

- Limit the number of vendors present at the event (depends on current guidelines from CDC at time of event planning)
- Provide a COVID-19 special rate for vendors, (Town Businesses discounted or free rate, out of town businesses and other vendors discounted rate. This would be

implemented to encourage our vendors to sign up and attend the event despite the hard hits they may have experienced this spring.)

- Limit the number of Contracts Purchased one stage, limited musicians, limited advertisements, etc.
- Consolidate beer gardens and stages to one location
- Locate new public parking options to limit the Bus Contract

These are some of my ideas to limit our costs for Haymarket Day while still hosting the largest community event. I am working under the assumption that the event planning will change monthly and must be reactive to the Governor's orders. I will do my best to anticipate changes that may arise, but I encourage Council to provide requests and suggestions as we continue to plan for COVID.

I would also like to request from Council the permission to provide a COVID-19 refund to the Haymarket Day participants if we were to be required to cancel the event. For example, if applications go live this summer and a second wave of COVID happens this could require us to cancel the entire event.

December 5th Christmas and Holiday Event – I expect this event to proceed as planned, however the Haymarket Day income will strongly dictate the size of this event. I will bring this event back up for discussion in the summer months when we have a better grasp on the COVID effects.

Lastly, I would like to request Council defer the remaining events budget to next fiscal year. This money was collected as event vendor fees and sponsorships and would significantly assist the FY2020-2021 Events budget. I will ask Roberto Gonzalez to explain our options for the deferral.



Highlights from the Town Council Work Sessions

- Approved Real Estate Tax Rate equalization from .146 per \$100 assessed value to .136 per \$100 assessed value.
- Included Transient Occupancy Tax in anticipation of early 2021 Hilton Hotel completion.
- Allocate \$339,571 for Town portion of sidewalk improvements on Jefferson Street.



Considerations for FY2021 Budget

- Focus on completing the Jefferson Street Pedestrian Street Project
- Address increasing Real Estate Assessments by equalizing the tax rate. (Some homeowners will still see an increase)
- Provide exceptional professional service to our residents and businesses
- Focus on updating Comprehensive Plan to ensure we continue moving the Town forward with up to date guidance for staff.



Town Services and Programs

- 24/7 Public Safety Services
- Community Planning, Zoning and Engineering Services
- Business and Economic Development assistance
- Trash and Recycling Collection
- Tourism Development: Historic Museum and Exhibits and Four Community Events a year
- Historic District Infrastructure Maintenance: Street Lights, Public Refuse Receptacles, Street Sweeping Maintenance, Town Streets, Brick Sidewalks, Public Parking Lots








Real Estate Tax Rate per \$1 Assessed Value
