Whereas, community organizations and grass-roots support are vital to continuing the flight against suicide and the loss of young lives; and

Whereas, reducing the stigma by discussing suicide and increasing the awareness of available resources for those suffering from suicidal thoughts is an important prevention effort;




Track Arrangement





Person Throughput by Travel Mode (I-66 Eastbound AM Peak Hour, 2040)















Ridership Forecasts









STAFF REPORT

Agenda Item Change Order Proposal Project #14096 Rinker Design Associates, P.C. Town of Haymarket Town Center

Background

The Town of Haymarket retained Rinker Design Associates (RDA) to provide Engineering Services for the Haymarket Town Center Redevelopment project. At a meeting between RDA, the Town Engineer and the Interim Town Manager on September 8th utility issues associated with the site were discussed. It was recommended that site engineering should include a water and sewer layout design that would accommodate establishing independent service to each structure on the site. Currently the structures share one utility meter. Staff asked RDA to prepare a change order proposal to include this work.

Factors

The opportunity to make these changes will be most cost effective at the time the rough grading on the site is underway. Having the ability to individually meter and bill the respective buildings for water and sewer service will allow the Town to defray costs it assumes under some of the existing lease agreements. Independent connections will also be beneficial should the Town elect to sell the buildings individually as part of the financing plan for the Town Center Redevelopment.

Fiscal Impact

The change order fee is \$4,970.82. The total contract amount is \$268,890.57. This is the third change order issued on this contract. A breakout of prior change orders and billing status as on 9/30/2016 is included in this report.

Recommendation: Approval of the change order.

SCOPE

The purpose of this Change Order is to propose a water service and sanitary sewer layout for the Town Center Redevelopment project. The scope of services is as follows:

- Utility Investigation/Survey: RDA will coordinate with Mid Atlantic Utility Locating, LLC to utilize surface geophysical and electromagnetic techniques to determine the existence and mark the location of six (6) sanitary laterals by accessing via clean-out trap. The field crew will also investigate one (1) requested hand-hole previously off-limits during prior site visits and will attempt to locate any water service lines that were not marked during prior site visits. Due to the size of the existing water service lines, it may not be possible to locate them. RDA will field survey the new utility designates and incorporate this information into the base mapping for the site.
- Site Utility Plan: RDA will analyze the location of the existing laterals and water services in conjunction with the proposed site layout and design. RDA will then prepare a utility plan for proposed water services and sanitary sewer laterals to each of the four buildings on the Town Center property. The intent is for each building to have a separate lateral and water meter. These services will be designed in accordance with Prince William County Service Authority (PWCSA) standards and include appropriate details and the standard PWCSA plan sheets. This design will be incorporated in to the overall site plan for the Town Center property and submitted to the Town and outside agencies including the PWCSA for review and approval.

ESTIMATED FEE

The fee for this change order is \$4,970.82. The new total maximum price for this contract is now \$321,886.39.








- <u>Village of Haymarket Phase II.</u> The developer has been working with the Town Engineer to obtain approval for the lighting plan. Dominion Power will be installing the streetlights.
- <u>Sheetz.</u> Currently receiving comments from agencies. Final review incomplete.
- Payne Ln. Met with two different groups who are interested in developing the property.
- <u>Zoning Ordinance.</u> The Berkley Group would like to bring the draft ordinance to the Planning Commission and Council in November and December, possibly holding a joint work session. We could start the timeline for adoption as early as possible in January, with public review and comment in February, and final adoption in March or April, depending on input from the PC and TC.
- <u>Subdivision Ordinance.</u> Will be a separate chapter of the Zoning Ordinance.

Development Review

- Zoning Permits. Approved zoning permits for residential fences and sheds.
- <u>One-Mile Review</u>. Met with developers for the Carter's Mill Active Adult Community planned for the property just west of the Town on Rt 55. This rezoning was submitted to Prince William County on August 8, 2016 and is currently under review. We will be providing comments.
- Architectural Review Board. Approved 2 Certificates of Appropriateness at their meeting October 19.

Transition Plan

- The new planner (Susannah Smith) started September 26th. We are continuing the transition of projects through early November.
- The changeover from Marchant Schneider to Ms Smith as Zoning Administrator is scheduled for the November meeting of Council.

INTERIM TOWN MANAGER'S REPORT HAYMARKET TOWN COUNCIL MEETING NOVEMBER 07, 2016

Report Prepared October 26, 2016

The following is a summary of the activities of the Interim Town Manager and Administrative Staff covering the latter part of September 2016 through the preparation date of this report.

- Restructuring personnel and procedures in the Town Office as a result of staff changes.
- Implemented improved security procedures. This included new security logins to access vendor accounts, state agencies providing health care and retirement benefits, financial institutions and other governmental agencies the Town collaborates with.
- Vendors, our professional services contractors and outreach to other localities has afforded orientation and training for staff related to new assignments. Formal training in certain areas is scheduled.
- Real Property Taxes were prepared and mailed. Approximately \$290,000 in revenue was billed.
- Payables and payroll were completed with minor disruption during this period.
- Staff is documenting procedures as they are implemented for future reference and to ultimately compile a procedures handbook for office operations.
- Vendors' lists and other contacts are documented and re-organized.
- Banking services are expanded to include electronic deposits from the Town Office, including check scanning. Past banking and credit card statements were reconciled.
- Several Human Resource issues were resolved.

- During this period staff responded to 13 requests under the Virginia Freedom of Information Act (FOIA).
- An addendum was negotiated with The Berkley Group to expand planning and zoning services to include staffing the Planning Commission and Architectural Review Board Meetings.
- A meeting was held to discuss billing disputes with a contractor.
- Maintenance issues at two rental properties are being addressed.
- 11 resumes for Clerk/Treasurer and 34 resumes for Town Manager were received, reviewed and correlated. The Interim Manager met informally with several candidates to answer questions and tour the Town. Council conducted two interviews with Town Manager Candidates.
- Budget status reports were prepared and distributed to the Finance Committee
- Exploring various funding options for the Town Center Development.
