**A RESOLUTION TO RECOMMEND THE APPOINTMENT OF A JOINT PLANNING COMMISSION COMMITTEE FOR THE REVIEW OF CPA; PLN2009-00267 AND REZ; PLN2010-00182; HUNTER AT HAYMARKET**

WHEREAS, the Town of Haymarket is empowered to make and adopt a comprehensive plan for the town, and to that end all plats and re-plats made subdividing any land within the town, or within one (1) mile thereof, into streets, alleys, roads and lots or tracts, shall be approved by the Town prior to recordation in the office of the Clerk of Prince William County, Virginia; and

WHEREAS, the planning commission of any locality may cooperate with local planning commissions or legislative and administrative bodies and officials of other localities so as to coordinate planning and development among the localities, and planning commissions may appoint committees and may adopt rules as needed to effect such cooperation; and

WHEREAS, Prince William County is in receipt of an application to change the comprehensive plan Designation of several parcels that lie within and immediately adjacent to the Town's limits, and within one (1) miles of such limits, CPA; PLN2009-00267; HUNTER AT HAYMARKET; and

WHEREAS, Prince William County is in receipt of a companion rezoning application for those several parcels that lie within and immediately adjacent to the Town's limits and within one mile of such limits, REZ; PLN2010-00182; HUNTER AT HAYMARKET; and

WHEREAS, The Town Council of the Town of Haymarket deems it advisable to coordinate the review of those application among the localities;

NOW, THEREFORE, BE IT RESOLVED that the Town of Haymarket recommends the appointment of a joint planning commission committee to accomplish said review, composed of representatives of the planning commission of Prince William County and the Town of Haymarket.


