Gene Swearingen-Town Manager-FY2011 Budget Presentation

The Town Manager thanks the Town Council and the staff for this budget. "Haymarket is in great financial condition. This budget reflects a limited burden on the tax payers. No tax rate increase is proposed. There are projections of \$360,000 for the meal's tax. 1/3 of our budget revenue comes from outside the Town in the meal's tax and cigarette tax." Residents get local police protection, garbage removal, care of property that is owned by the Town, mowing, and at a burden of approximately \$48/month per household. In addition, the Town provides Haymarket Day; a summer concert series; but most importantly a small beautiful town that maintains its small values."

She feels as the Town Manager, council has done a good job keeping the Town in the black. However, she doesn't recall any discussion of the priorities for the coming fiscal year; she only saw it published in the newsletter. She does not feel the priorities listed in the newsletter are agreeable. The Town Center Property has a repair budget of \$100,000 and an annual debt service of \$100,000, there is no money going toward a reserve for when this property is sold or the Town Hall section is rented, there has to be a plan. She feels this is short sighted of the council.

Trailer discussion, the offices did fine for years right here, now the Town Hall offices sit empty Monday through Friday; the minimum and mid-range compensatory plan the Town's mentioned are not comparable to us, he doesn't think this is a fair comparison.

Last Thursday we received a letter from the property owner requesting an additional 6 months to complete the punch out items in the violation letter. Mayor understands the financial state of the economy, but still feels he should install the 2 lights. Clerk refers to site plan and confirms there are 3 lights to be placed on Washington Street in front of the property.

Treasurer

Per council's request, he has been looking at the structure of our funding. The Town has close to \$900,000 in street-scape funds in an account at BB&T. He turns the meeting over to Ellen Winston with Fauquier Bank.

- Ellen Winston-The Fauquier Bank  
There are no fees at Fauquier Bank and all deposits are collateralized. Fauquier has sweep accounts, whereby each evening at close of business funds are swept. The annual percentage rate is .75. There is no adjustment on the account, the rate is a "bank set rate", the rate has not changed in at least 1 year, and however, it could change at any time. They are not inclined to lower that. There is a target balance. You can sweep any amount. He would like a feed back on what the council would like to do. Mayor suggests that we provide the Town Council in writing.




