#### **Prince William County Assistant Fire Chief Bowman**

Cole asks about the status of the lawsuit between Prince William County and the Gainesville Volunteer Fire Department. Chief Bowman does not know the exact date for trial. The county is working with a group of volunteers; they are operational every Wednesday night. The funds being requested would be dedicated to Station 4 only. Money is going to be used for that station only. Equipment would stay at the station even if the volunteers took over the station.

\$40,719 the difference will be made with operating funds from that station. The Town has \$35,423 in ATL grant funds

For the record, Edwards would like the funds to go to Gainesville, Station 4.

## **Trolley Committee**

Cole reminds that we have been awarded grant money.

The big question is, If we walk away, after accepting the grant funds, are we liable for anything, they have assured us we would not be liable. therefore, the contract must be clarified and reflect that. We are looking at about \$30K would run the rest of the year to operate. This company offered their services, they would hire fire insure. We should assume that we will get no help.

\*\*What does the trolley really do?

We aren't relieving congestion. The trolley provides a service and connects the communities. Cole comments that he thinks it is time we go beyond our borders. We can already say we are exchanging in extra Haymarket activities. No public transportation runs on its own merit.

## **Edwards**

As a side bar, Kim from Cupcake heaven was asking about meal's tax money. Edwards asks where are we getting this money. We will have to give up in order to have the trolley?

#### Weir

First we need to establish if the Trolley is a want or a need. What needs are you putting at risk to get this "want". He's not thrilled with running a taxi service for Heritage Hunt and Wegmans on our dime. He does not think the formula is going to remain the same as far as the Town's financial input. Next cut is VDOT budget. He is concerned with the contract clauses. Until we have a contract in hand that is acceptable, he doesn't think its worth discussing. Audit must be provided and certified. All the financial aspect is cut by us. There is also a matter of scale. The rider ship numbers are tiny, 30/day or less. He doesn't think its energy smart. This area is not conducive to transit. He can't in good conscience vote for this. Cole responds that from his argument Weir will probably never want a Trolley.

#### Leake

Leake does not see this as a want or a need; he sees it as a vision. Why not use the meal's tax money for this. We would be able to get something for advertising eventually. He sees it as a positive and a plus for the Town.
