They ask respectfully after such signs shall not exceed such square area, 58-343 (b) (11) (c), they ask that we add the text "exclusive of non-internally lighted signs. She feels this will encourage the ultimate goals of the ARB and the Town as a whole.

It really is a zoning issue; you are not in compliance with the buffer requirements. If you go to the discussion on the comp plan this is why there is a Commercial Transitional District. The question is do you choose the commercial side or the residences side. He is looking for a compromise. He is concerned about approving this without limitations

Cole notes that even if the buffers were there it wouldn't solve the issue.

Leake also comments that we didn't request the bank to limit the hours of their teller machine.

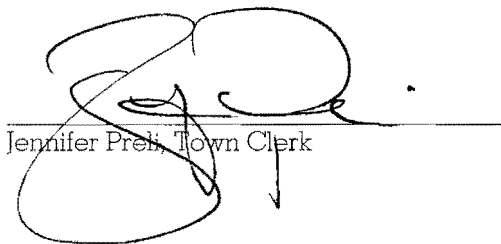

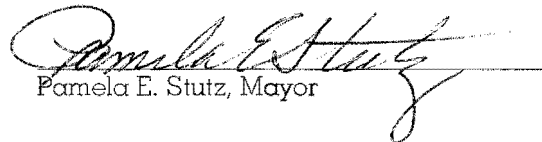
