US Census Bureau-Isabel Almendarez speaks to Council about the partnership with the Town. She thanks the Board for allowing her to speak. They need local governments to raise awareness of the necessity of getting the Census returned quickly in April 2010. There will be only 10 questions. The need is for redistricting, \$400 billion annually that comes to state and local governments. Some people may receive the American Community Survey, this survey replaced the long for of the Census. The long form is sent out to approximately 250,000 households each month annually.

Citizens Time

Gerry Kennedy, Developer of Old Towne Centre

He first stood here in April 2005 and spoke of Haymarket's potential as a walking town. We've all gotten to know each other pretty well and now we are down to the 5-yard line. The contract needs an extension to move forward, he is requesting that extension tonight. He has the project in the hands of several banks, but needs a live contract to continue working with the bank.

Shuryn asks about a time-line with regard to his current financing. Mayor reminds that the council did proceed last month with lease signing and appropriations for repairs and maintenance. Every bank he has spoken to says this is the economy, it is not the project. It is because this project relies so heavy on retail. His commitment is as strong now as it was in 2005.

Mayor seeks the Town Attorney opinion. "The contract has expired". The contract cannot be extended from a legal standpoint without holding another public hearing. Council could vote and authorize the Mayor or TM to execute appropriate documents evidencing the sense of council. So a vote along the lines of "a sense of council". However, a new contract would be subject to another public hearing. His intention to complete this project.

Vazquez doesn't see how the inability to secure financing whether or not this is good for the town. he is seeing it across the board all over the country. He thinks this project will make or break the town. He feels the best course of action is to support the Kennedy project.

Cole would like to find a strategy to get the banks to make a decision. He wants to know what the town can do to leverage the banks.

Kennedy states that first of all there needs to be a viable contract. Mayor wants to make it clear to the banks that the Town is moving on. He mentions the possibility of leasing some space from the Town, then subletting for the Town and making the Town money in the end. He is willing to work toward the mutual benefit of his project and the Town. Vazquez likes that idea. The Town is not a good landlord. He would like the Town to look into this further.

Cole would want to hear how this would be constructed and operated. Vazquez assumes that this would just be treated as another lease.

Linda Landwehr

Mayor thanks Linda for her assistance with the August 1 bus tour. She recaps what she said last week, that we need to move on. At some point you have to put on your responsibility hat and start fulfilling obligations. She compares to Quarles, they are moving on building like crazy. She stands by that thought.

Adrianna Carvajal

She supports the Kennedy project. She is all about that. Right now she has 41 days left to open her school. She is uncomfortable not having answers.
