St. Paul's Episcopal Church, 6760 Fayette Street, parking lot - Rev. Jones states there are two large lights, one on the house and one on the church. Councilman Utz would like to be sure the three foot canister lights go in the motion. Councilwoman Scarbrough and Councilman Mohr agree.

Councilwoman Scarbrough moved to approve with three-foot canister lights and a \$1000 performance bond is required, second by Councilman Mohr. Yeas: Shepard, Mohr, Bailey, Utz, Scarbrough, Stutz. Motion carried by 6/0 vote.

McDonald's Restaurant, 15201 Washington Street - Terry Winfield presented elevations for the restaurant. All brick, roof and materials are to match the shopping center. Councilman Mohr asks about screening for trash cans, it will have a brick wall, will include vented circular ornament on the pediment. One menu board to face Route 15 - Councilman Mohr asked about internally illuminated signs. They may be able to do a monument style sign. Mr. Winfield will look at putting screening at two back side doors.

There is ten feet between the building and drive through [delivery doors]. Mayor Kapp suggests a wall. Mr. Winfield says that is their delivery entrance. Councilman Mohr states the delivery entrance door is on the rear in the Winchester facility.

Councilwoman Stutz asks how many designs they have done. This is the second.

Shrubbery will be on Route 15 side. Councilwoman Stutz suggests a six panel colonial design doors on Rt. 15 side. Mr. Winfield states they will be painted the same color as the brick.

Councilman Mohr asks them to put in fake window between the window and the service doors. Mr. Winfield can landscape up against the wall, would be tall planting.

Council requirements:

- (1) Two [service] doors six panel colonial doors same color as brick, on Rt. 15 side,
- (2) Space between doors and service doors to be landscaped to soften,
- (3) Other side [back] shrubbery in green space,
- (5) Sandwich menu board in brick façade casing.

Councilman Mohr asks portico color. Was white changed to beige [trim]. Council likes the beige trim. Councilman Mohr asks what color the McDonald's sign is. White was the answer.

Councilman Utz moved to approve elevations as noted will match the rest of the shopping center, second by Councilwoman Bailey. Yeas: Shepard, Mohr, Bailey, Utz, Scarbrough, Stutz. Motion carried by 6/0 vote.

Councilman Mohr asks why Burgess & Niple has given us a proposal for plan review for McDonald's. Town Clerk says we don't have a staff engineer to review.

Citizen's Time

Connie Henderson, regarding gray house, states there are no roaches, rats, no mice. The house color was the town's idea Mr. Gossom told her. The house has four bathrooms. Mayor Kapp says the Council does not want to address that now. Alan has put in new bathrooms, heaters, smoke detectors. Mayor Kapp does not see any problem with the house. Councilman Mohr asks if we can repaint the house to make it more pleasant. Can we landscape it and put up a small picket fence and designate a parking area. Ms. Henderson says there is no dirt there for a garden or flowers. Mayor Kapp says the driveway will be paved [behind hardware store building]. Councilman Mohr to chair committee for ideas to improve the landscape.

Rev. Jones states he appreciates the Council and ARB for the quality and appearance of the new homes with brick fronts and colonial look. He is concerned with the brick color for the shopping center.

Councilman Mohr asks why Mr. Leaberry is changing the color of the bricks. Councilman Mohr doesn't like the color of the brick sidewalks.

Ms. Crafton-Masterson comments Ryan Homes, NVR, has just won an award for outstanding homes. She says Council and ARB did a good job with these homes [18th Century Haymarket]. She thinks the brick ought to be considered in more detail.

Darlene & Jim Robinson state they are trying to buy a one half acre parcel from Jim Durham [subdivision request submitted].

Mayor Kapp asks Atty Arledge if we must do the whole thing if there are no roads now. Atty Arledge states no if there are no roads. If requirement not applicable. Mayor Kapp states there will be water and sewer easement, driveway easement. Atty Arledge to look at it.

Councilman Mohr asks what it would be for. Mr. Robinson wants a business for parking a couple of trucks and equipment. It is heavily wooded, Mayor Kapp states. Rev. Jones asks if the buffer is on their side of property or just the church. Right now Robinson wants to fence and park equipment. Councilman Mohr says we wold not permit outdoor parking area.

Mayor Kapp asks Atty Arledge the difference of parking and storage and if a business leaves equipment/vehicles. Atty Arledge states there is a difference for a business of outdoor storage and equipment parking for a business. Mr. Robinson wants to have his business in town, he is driveway paving contractor. Mrs. Robinson asks if they should submit their business license. Mayor Kapp states yes. Councilman Utz asks if there would be trailers, low boys, Bob Cat., etc. parked there. Mr. Robinson says 85% of equipment is used daily and leaves the lot. Councilwoman Bailey asks with subdividing PC can't do anything unless subdivision is approved. Mr. Robinson would submit a business license as a tenant of Durham.

Councilman Mohr is concerned about the parking equipment behind the houses on Fayette Street. He has a problem with the odor of asphalt.

Councilwoman Stutz asks what steps they need. Mayor Kapp spoke with Mr. Durham for subdivision for three lots. Will come in November 22. Mr. Robinson will submit a business license application for the special use. Councilwoman Stutz asks what are the requirements for special use. [The code was read for requirements]

Councilman Mohr wants notification to adjoining land owners of the subdivision property.

Ms. Barringer asks when we will have a coat of asphalt on Washington Street. Mayor Kapp states one week. They are waiting to move poles, install curt and then pave.

Ms. Robinson asks if Atty Arledge will get in touch with Jim Durham. Mayor Kapp will be sure Jim Durham knows what is required. Atty Arledge will review deed of subdivision.

Planning Commission

Councilwoman Bailey states they had a continuation November 21, 7:00 p.m. for archaeological study, B-3 district zoning, definition for antique and collectible, readdress I-1, B-2 and B-3 district, update square footage for businesses.

Architectural Review Board

Proposal, dated August 30, 2000, from architect for town center, new town hall façade. Councilwoman Scarbrough would like to hire Mr. Newlon for the project.

Councilman Mohr moved to approve agreement with Richard Newlon for Town Center at \$90 per hour for architect time \$45 for drafting time, second by Councilwoman Bailey. Councilwoman Stutz does not like it open ended. Councilman Mohr

Mayor Kapp is concerned about gifts. Ms. Crafton-Masterson states she bought 12-14 gifts. St. Paul's has accepted for us to use the Parish Hall. Roslyn Langlois is honored to be a part of our celebration, and her daughter. Also Councilman Utz will be singing "I'll be home for Christmas". The opening celebration is in the Town Hall parking lot. Sarah suggested Mountain View kids make ornaments for the tree. Ms. Crafton-Masterson says that is in Mary Carter's hands. Councilman Mohr asked about the town ornament. Ms. Crafton-Masterson says she hasn't gotten to that.

Ms. Crafton-Masterson spent thirty one hours since October for in-kind contribution for the museum.

The ARB asked the Commission for input with the archaeological study.

North Fork - had 23 participants - contacted Izaak Walton people for help.

Councilwoman Stutz asks where are the by laws – regulations of Historical Commission. The draft was done some time back. Gave them authority to review historical aspect. Councilwoman Stutz would like to talk to the PC and ARB to define the process.

Councilman Mohr asked Councilwoman Bailey to add to PC agenda.

Police Department

Councilman Utz wants Council to consider how to arrange for Chief Roop to be in charge of his finances, budget, training. He proposes to give him parameters to work in and let him do what he needs to do. Whether his fault, the treasurers fault, bills are not being paid and collection notices are coming. At end of fiscal year he report back to treasurer. Roop would (1) run budget, (2) checkbook, (3) change phone number billing, (4) mailing address. Chief Roop or Vice Mayor will sign checks. Councilman Utz will go over with Roop monthly. Councilwoman Stutz asks if it is one or two signatures on check. Council says a dual signature. Councilwoman Scarbrough says use a single signature up to a certain amount.

Councilwoman Stutz asks when does revenue come in? All year states Mayor Kapp. Mayor Kapp thinks fines will support the department. Councilman Utz says he wants a fast decision on this. Councilwoman Stutz says we need this in writing for December 4th meeting and not make a quick decision.

Councilman Utz will work up a process. Councilwoman Stutz asks what our charter says. Appropriations over \$100 is by vote of Council. Atty Arledge states he takes that as a line item on budget.

Councilman Mohr states he brought this up last spring about the Historical Commission and problems. Councilman Mohr suggests Sgt. Putnam make up a file of grant process to leave for future personnel.
