Mayor Kapp opened the work session for the budget at 7:47 p.m.

Gainesville Ruritans

Don Holmes and Ellen Wilson presented the Ruritans proposal for Haymarket Day. The Ruritans will do all the entertainment expense, trash, parade, parking, food and insurance The town event planners need to know about pony rids, moon bounce, petting farm, kids events. The town does the crafters, kid's entertainment, porta potties, help with trash.

Councilman Utz states he has seen the inflatable moon bounce obstacle course, it is 30 yards long with a wall at the end. Adults enjoy it as well as kids. Also there is rock climbing, a monument with harness. Councilman Utz will get the information on these.

The Ruritans want the town to do the portable potties and trash pick up (keeping bags changed.)

Advertising - The Ruritans will do nothing more than the Gazette. Any additional advertising will be the responsibility of the town.

There was conversation about an outstanding bill (for custodial person) at Pace West School, they are looking at the town to pay. The Town Clerk states she reserved the facility for a "rain location" and since it did not rain she did not use it. Mr. Holmes states he reserved the school for the parade line up and the use of the bathroom for the parade participants. (The Ruritans are responsible for the bill.) Councilman Jasionowski suggested reversing the parade to end at the school, rather than begin at the school and possibly begin at the Leaberry's lot or start line up at Fayette Street.

Expenses FY 2001

Bluemont - Councilman Jasionowski asks if we can do the same on our own rather than use Bluemont and have to pay their fees. Mayor Kapp states we can get advertising contacts and the \$5,000 from the state. Mayor Kapp would like to give Bluemont a year and go through the summer series. Ellen Wilson, Bluemont Chairman, states Bluemont has its reputation and acceptance at the Virginia Commission of the Arts.

Ms. Wilson states the Spring Festival is a loss leader, that was part of the agreement with Bluemont. We need to look at carefully what we want to continue with in 2001. The concerts are scheduled for the second Saturday of the month for June, July and August.

Three summer concerts July, August, September 2000 plus May 2001 (Spring Festival) are scheduled for FY 2001 budget with \$3200 to be raised, \$5000 commitment from the Town Council and \$5000 grant from the Virginia Commission of the Arts.
