### SITE PLAN

Councilman Price moved to approve the site plan for Sheetz subject to approval by the regulating agencies of DEQ, Health Department, VDOT and PWCSA. Vice Mayor Bean seconded the motion. All were in favor. The motion carried.

## HISTORIC DISTRICT OVERLAY

Councilman Price advised that the Planning Commission recommended that the Historic District Overlay be adopted as written by the Town Attorney.

Councilwoman Leonard moved to approve the Historic District Overlay. Councilman Price seconded the motion with discussion.

Councilman Bean wanted the Town's Citizens to have more input.

Mayor Kapp advised that the purpose of the Public Hearing held earlier in the evening was for that reason alone. As it had been advertised in the Journal Messenger on the 20th & 27th of December, 1993 and flyers were passed out around Town, more than enough notice was given to the Town's Citizens to attend the Public Hearing and voice their opinion.

The Ordinance regarding the Historic District Overlay was passed in a 4 to 2 roll call, with Vice Mayor Bean and Councilman Crouch voting "no".
