The November 1, 1993 meeting of the Haymarket Town Council began at 7:30 p.m., promptly following the Joint Public Hearing of the Town Council and Planning Commission.

Mayor Kapp led the prayer and pledge of allegiance. The Roll Call was taken finding all members present. Councilman Hancock moved to dispense with the reading of the October 4, 1993 minutes. Councilman Shepard seconded the motion. The motion carried.

PLANNING COMMISSION

Councilman Price reported for the Planning Commission on the following:

- 1) Approved Building Permit for Bob Seffinga.
- 2) Advised that Q-Stops Sign Permit Application was pending due to a footing inspection.
- 3) Numerous requests by Town citizens for traffic signs stating "Children at Play" and "No thru Street".
- 4) Planning Commission sees no reason to change the Town's current ordinances regarding signs with regards to VDOTS letter submitted in October.

HISTORICAL COMMISSION

Sarah Turner, Chairman of the Haymarket Historical Commission reported that the Commission will be holding a Christmas sale to benefit the Commission and the "Caboose". The Commission is trying to raise money to have the Caboose wired for electricity.

CITIZENS TIME

Nancy Bailey asked that the Town adopt an ordinance with regards to "Stop Work Orders" in order to prevent issues arising as in the case of the Lyons property demolition. Mayor Kapp said that he would have the Planning Commission look in to it.
