Councilman Hancock moved to dispense with the reading of the June 14, 1993 minutes. Councilman Crouch seconded the motion. The motion carried.

Councilman Hancock moved to dispense with the reading of the minutes from the Joint Public Hearing held June 14, 1993. Councilman Price seconded the motion. The motion carried.

HAYMARKET PLANNING COMMISSION

Councilman Price reported for the Planning Commission on the following:

- Planning Commission is currently reviewing Sec. 7 of the Town's Rezoning Ordinance for the necessary changes to be made in order to reflect the Town's new Gross Receipts Business License Tax.
- 2) Building Code Violation 6710 Bleight Drive:

P.A. System

Violations

Building Code Violation - 6710 Bleight Drive

State Department of Environmental Quality Litter & Recycling Grant

Councilman Hancock moved to approve a cooperative program, under the coordination of Prince William County, to have funds previously allocated to the Town (\$195) forwarded to the County.

Councilman Shepard seconded the motion. All were in favor in a roll call vote.

Piedmont CD

A CD held by the Town at Piedmont Savings will come due July 27, 1993. Councilman Price made a motion to not to renew the CD, but deposit the funds into an Interest Bearing Account at First Virginia. Councilman Shepard seconded the motion.

NOVA AMPHITHEATER

A "Thank You" letter was received thanking the Town for it's generous support by purchasing a bench for \$500 in the Town's Name.

RECORDS MANAGEMENT

The Town Clerk received information from the Virginia State Library & Archives on the management of the Town's official records. Records Management procedures will be put in place by the Town Clerk to conform with the Virginia Public Records Act.

DISASTER PLAN

Procedures were discussed on the development of a "Disaster Plan" for the backup of information on the computer should a disaster strike. Procedures for protecting pertinent Town documents were discussed as well.

The Town Clerk will develop a "Disaster" backup plan.

CLEANING OF TOWN HALL

Councilwoman Leonard moved to approve the cleaning of Town Hall at least quarterly or sooner if needed. Councilman Price seconded the motion. All were in favor in a roll call vote.

AMERICANS WITH DISABILITIES ACT

The Town's plan needs to be put into effect by the end of 1993. Mayor Kapp presented his idea of how Town Hall may be brought into compliance with the ADA.

Council discussed numerous ideas. Councilman Price will bring in surveys and look into obtaining a new furnace for Town hall.

POLICE REPORT

Chief Tatum reported on the following:

- New "Summons" forms must be in use by October 1, 1993.
- 2) Councilman Hancock moved to approve Charlie Bockey as full-time Police Officer. Councilman Price seconded the motion. All were in favor in a roll call vote.
- The Police Department has been working the Townhouses looking for delinquent Town Tags.

ORDINANCE TO AMEND AND REENACT THE CODE OF ORDINANCES

Councilman Hancock moved to approve the resolution to amend and reenact **Section 8-4** of the Town Code regarding the adoption of State Laws. Councilman Crouch seconded the motion. The motion carried.
