HAYMARKET TOWN COUNCIL MEETING

JUNE 19,1989

After the Prayer and Pledge of Allegiance, the June 19,1989 Town Council Meeting which began at 8 p.m. found all Council Members present. Minutes of the previous meeting were read and approved. The Treasurer reported a balance of \$74,559.95 in the General Account at the end of May. She also reported bills to be paid, they were;

1. Haymarket Service Center, work on police cruiser -- \$173.34

2. Gossom's Hardware, Cleaning Supplies, T. H.----\$ 15.03 Bird made a motion to pay the bills, seconded by Kapp, the motion carried unanimously in a Roll Call Vote. BUSINESS LICENSES:

1. Haymarket Baptist Church , 14800 Washington St., requested a Business License for a Pre-School for 3 & 4 year olds. This was turned ove

to the Planning Commission to review.

2. Bird made a motion to approve a Business License for Clint Bolt and Toni Gossom Trading as B & G Construction, at 15000 Washington St., Office #1, nature of business is General Construction, this was seconded by Kapp, the motion carried.

3. Another license for Clint Bolt, Rick Hess and Toni Gossom, Trading as Business Builder's Coupon Service, B.B.C.S., at 15000 Washinton St, office #1 was approved. Bird made the motion to approve it, seconded by Kapp, the motion carried.

SIGN PERMITS:

A Sign Permit for Unclaimed Treasures, after being recommended by the Planning Commission for approval was granted after Bird made a motion to accept it, seconded by Hancock, the motion carried.

A Sign Permit was approved for the Consignment Collection, after the Planning Commission approval. Bird made the motion to accept it, secon-

ded by Hancock, the motion carried.

Bird made a motion to accept a Sign Permit for It's Stained Glass

after the Planning Commission's approval 1 by Hancock, the motion carried.

Hairmarket also applied for a Sign Permit, the Planning Commission recommended approval subject to the Right of Way Dedication. Also it was to be made structionally sound. Bird made a motion to accept the recommendations of the Planning Commission, seconed by Hancock, the motion carried.

BUILDING PERMIT:

Randy Rains on Hunting Path Rd. applied for a Building Permit. He wants to build a wood deck, 15 X 10. Bird made a motion to accept the recommendations on this from the Planning Commission and grant him the permit, this was seconded by Hancock, the motion carried. LORENE PAYNE:

Lorene Payne spoke on a Public Hearing to be held on June 20, at 7:30 p.m., at the Board of County Supervisor's Chamber on the amendments. to Proffers for Melbourn Associates. This was 8 acres rezoned from A-1 to

Mrs. PAYNE ALSO SPOKE ON THE Freedom Of Information Act. She also mentioned that there would be a meeting of the Steering Committee on June 29 and said if the Town wanted to send any specific messages, this would probally be the time to do it. Mayor Freeborn asked Lorene to write a letter of the issues agreeable or disagreeable to the Town. Lorene agreeded to do this and get the letter back to Council by the 26th of June.

ANNOUNCEMENTS:

The Mayor DELIVERED A MESSAGE FROM Mr. Parrish, letting the Town know that a light will be put up on Rt.55 & 15, by the end of the year. The Mayor thanked Mrs Melton who had worked on this for a long time. A letter was also to be sent to French Slaughter's aid, Mr. Goolrick,

thanking him for his help.

Ron Young from Jetco adressed Council saying they had purchased a JETCO: piece of property but it would probally be Sept. 1989 before they left and they would like to operate until then. Officer Damron reported that there are 2 campers on the property, one comes and goes, the other is stationary. Bird sind that he had no problem with the Office Trailer staying on the property until they re-located and made a motion to extend the time of the Office Trailer until the end of Sept., this was seconded by Kapp, the motion carried. Then Bird made a motion that the campers be moved immeadiately, this was seconded by Crouch, the motion carried. Thanks;

The Mayor thanked Alan Gossom for cleaning up the sidewalks and was

informed that Costello did half of it, both thanked.

CALLED FOR MEETING:

Bird made a motion to hold a Called For Meeting on June 26, at 7p.m. for the purpose of adopting the Budget and the letter written by Lorene Payne for the Board of County Supervisors, this was seconded by Kepp, the motion carried.

EXTENSION:

Lynda Farr asked for an extension on her temporary Occupancy Permit. Kapp made a motion to extend it to the first meeting in Sept., this was seconded by Bird, the motion carried. Lorene Payne said she would need a final site plan during these 60 days, Lynda was to get her engineer to prepare the site plan. Also she was to prepare a letter of credit for her parking lot paving. REPORT:

Richard Bird gave an update on the Linton Hall Amendment, and other

items concerning the Town of Haymarket.

CORRESPONDENCE READ:

The Mayor read a letter from the Virginia Telephone Association, a copy of this will be left in Town Hall. She also read letters from Charles Colgan and Penny Conote regarding the Blinking Light
