HAYMARKET TOWN COUNCIL MEETING JUNE 5,1989

The Haymarket Town Council Meeting began at 8 p.m. After the prelimiaries, Roll Call found all Council Members present. Minutes of the previous meeting were read and approved. The Treasurer reported the following bills to be paid:

1. Gossom's Hardware, items T. H. & P.D -----\$2.88

2. EMBASSY AUTO WASH, WASHING POLICE CRUISER-----\$10.50 Councilman Bird made a motion to pay the bills, seconded by Councilman Ronald Hancock, the motion carried in a Roll Call Vote. CITIZEN'S TIME:

Glenwood Bear spoke in Citizen's Time, he thanked Town Clerk for the piece in the newspaper on the History of Haymarket. He would still like to see the Town purchase a video. Asked Richard Bird about cleaning up the Fire Dept. Spoke on trucks and swimming pool equiptment on a lot on Washington Street, saying they are getting worse all the time and he would like to see something done about it, Bird offered to talk to them. Asked if the Board of Zoning Appeals Name Plates had been made yet and Mayor Freeborn answered that they had been. He then mentioned that at the last meeting of the Board of Zoning Appeals they had no plans until Sequoia brought them in. BUSINESS LICENSES:

1. Bird made a motion to grant Kelly Davall a Business Licenses for "Unclaimed Treasures", at 14950 Washington St., Office #202, the nature of business will be; Antiques, Classics & Vintage Funkadelia, this was seconded

by Councilman John Kapp, the motion carried.

2. Bird made a motion to grant Darlene Hood a Business License for "The Consignment Collection" at 14950 Washington St., Office #100. Nature of Business will be Consignment & Resale of Children's Clothes. This was seconded by Kapp, the motion carried.

LORENE PAYNE:

Lorene Payne gave a Consultant Report bringing Council up to date on a lot of important issues. She stated everyone would be receiving a Census Form to be filled out in the mail and Staff did not feel the Town needs

to do their own study. She also spoke on the Washington By-Pass Study.

MR. SCHOFIELD:

Mr. Schofield addressed the Haymarket Town Council saying he would work with the Town in regards to the proposed Linton Hall Comprehensive Plan Amendment. The Mayor informed him that neither Richard Bird nor Lisa Whitfield who are on the Steering Committee had received the final comments from the Consultant Team. Mr. Schofield said he would see to it that they received them.

COUNCIL: Bird made a motion to establish a Filling Fee for the Board of Zoning Appeals of Four Hundred and Twenty Five Dollars (\$425.), seconded by Hancock, this was pending Attorney Steketee's report as to whether or not, it had to be advertised, etc., the motion carried.

Kapp made a motion to approve the Budget, seconded by Bird, the motion

carried, it will now be advertised and a Public Hearing held on it.

The Mayor announced that Gary Eddy will serve as Building Inspector until John Berger receives his certification from the State.

CORRESPONDENCE: 1. The Mayor read a letter from Smith & Davenport regarding the Codes. He made quite a few suggestions and told Council that they should go over them page by page and make any corrections before they are finalized. 2. A letter was read from Payne & Merchant in regards to their Bond.

for the Site Plan as requested by Town Council on April 17, 1989.

3. Another letter was read from the Virginia Municiple League regarding

the Liability Pool. 4. and finally a letter was read from the Virginia Dept. of Waster

Management regarding Litter Control.

NEW POLICE CRUISER: Bird made a motion to purchase lights and speakers for the new Police Cruiser in the amount of \$1,856.00, this does not include radio, this was seconded by Bean, the motion carried unanimously in a Roll Call Vote. OTHER BUSINESS:

Charlotte Adams of the Activities Committee said there would be a Halloween Parade on Oct. 28, from Town Hall to the Gainesville School, there

would also be pumpkin carving, etc.

In December, a Christmas Party would be held. Council went over Job Discriptions briefly.

Councilman Hancock mentioned that some proprety owners in Town need to cut their grass. Mayor Freeborn said letters could be sent to them. Council to think of Titles by the next meeting

OTHER BUSINESS, CONTINUED: Julie Mackall will be asked to clean up the fallen tree from her property that is hanging over the pavement.

Kapp asked about the School Bus parked behind Holladay's Market.
