HAYMARKET TOWN COUNCIL MEETING APRIL 17,1989

The April 17,1989 Town Council Meeting began at 8 p.m. with the customary Prayer and Pledge of Allegiance. All members of Council were presented with the exception of Councilman Sam Crouch. Minutes of the previous meeting were passed out, there were no corrections. The Treasurer reported a balance in the General Account at the end of March of \$76,378.17. She also reported bills to be paid, they were;

3. INTOXIMETERS, INC. MOUTHPIECES FOR ALCO-SEMSPR. \$33.00 Councilman Richard Bird made a motion to pay the bills, seconded by Councilman John Kapp, the motion carried unanimously in a Roll Call Vote.

BUSINESS LICENSES:

Councilman Richard Bird made a motion to grant a Business License to Wesley Beahm for part time Landscaping and Lawn Maintenance on Buck Ut's property, this was seconded by Kapp, the motion carried.

RECOMMENDATIONS, PLANNING COMMISSION:

The following were recommendations by the Haymarket Planning Commissi

1. They approved Rezoning of the Farr property.

2. Marika Evans has to move her sign back.

3. The Haymarket Pharmacy sign was approved.
4. The Allrite Insurance Sign was approved.

5. Supplees Sign must be set back.

CORRESPONDENCE READ:

Mayor Terri Freeborn read a letter from the Virginia Dept. of Transportation. They will hold hearings for the needs of interstate primary and urban highway systems in the Northern Virginia District.

The Mayor also read a letter from the U.S. Dept. of Housing pertaining to Fair Housing, a member of Equal Opportunity.

A specialist will contact the Town to set up a meeting for the purpose of solicting ideas.

Another letter was read from the Virginia Fire Board, they will hold a regional meeting at the Sheridan, Fredericksburg, located on I-95 and Rt.3, on April 27, at 7;30 p.m. The purpose will be to provide an opportunity to local Fire Services and Governing Bodies, the needs of Fire Services that can be addressed at the Local Level. Mayor Freeborn thanked Alan Gossom for helping to clean up the yard at Town Hall.

ADOPT-A-HIGHWAY PROGRAM:

Bird spoke on the Adopt-A- Highway Program. Alan Gossom was willing to clean up some part of the Highway but not the whole 2 miles going in the direction of Gainesville. Richard said the Town should try to find some others to help out. Litter pick-up will be 4 times a year.

WOMAN'S CLUB:

Bird made a motion to grant the Haymarket Woman's Club permission to put Haymarket, Va. and a logo of Town Hall on some tee shirts they plan to sell on Haymarket Day, this was seconded by Kapp, the motion carried. POLICE DEPT.

Officer Amos Damron asked what he should do about Junk Vehicles. Bird said he was oppossed to doing anything right now. Mayor Freeborn told Council to read the literature over on Junk Vehicles and it will be discussed at the next meeting.

Damron also wanted to know what more he can do for the Town ? Mayor Freeborn stated that she was well pleased with his work. Damron told Council that if there is anything else they would like him to do,

to please let him know.

Officer Damron has had several complaints about a Tractor Trailer parking at the house near Matthews Restaurant. Richard said the house is in the same rezoning that the Restaurant is in. Mr. Smith said they could park there if it is in a Commercial Zone, but they must buy Town Tags, however Mr. Smith was going to check further on this.

Damron spoke on setting up procedurer for selecting Police Officers. A meeting will be held at 7;30 p.m. prior to the 8 p.m.

Haymarket Town Council meeting on May 1,1989.

Ron Hancock brought up the subject of getting A bullet proof jacket for Damron. Richard said this probally would be done at the same time the new Police Cruiser is purchased, in the meantime Damron was asked to check on vests with the County and get some information on them. PRESENTATION:

Councilman Richard Bird who is on the County's Steering Committee, presented information on the Linton Hall Comprehensive Plan Admendment, and showed maps of the plans. He also mentioned that in the Town's Comprehensive plan that Checapeake Bay Preservation: should be included, saying we will have to make a stipulation in our Comprehensive Plan for it because the State of Virginia now is part of it and anything the State does, the Town and Counties will have to do also.

When asked if anything was mentioned about the old Antioch School being used for in the school plans, Bird mentioned No.

SITE PLANS:

The Site Plans for Payne and Merchant were discussed. Bird made a motion to accept the Site Plans, 2nd by Bean, the motion carried.

Mr. Smith and Richard Bird told Mr. Payne he must post a bond, a Letter of Credit would be preferred. Mr. Payne will present an estimate to Council on this. COMPLAINT:

The Mayor had a complaint regarding children running out of the front door at Bonnie and Clydes, into the street, saying there was no guard rail to stop them. She was told by Bird a safety rail could not be put up there because of it being state property but a control should be put on the front door to slow children down.

APRIL 17,1989 MEETING CONTINUES:

Councilman John Kapp had a few items to mention, one being that the Town should not accept sign permits unless location, etc. is on them; He also suggested putting a Mail Slot on the Front Door of Town Hall; the Planning Commission would like to use the recorder at their meetings.; Kapp spoke on Child Care, State of Virginia Resolution 137, covered in Town Ordinance under paragraph 6-1, for I-1 areas; Kapp said he had a phone call from a lady wanting to know if she could put a Mobile Home in an R-1 area, Council said a mobile home could not be allowed, there were several in Town under the Grandfather's Clause, but when they left, none could be replaced.

Mr. Fewell Melton spoke on water running down Jefferson St. onto his property. Bird told him the drain in front of the Bank was stopped up, about a month ago there was a big puddle there, ralso the man hole on the other side is full of gravel, we need to get a vacumn up here to clean them up. Bird will check further to see what else can be done.

EXECUTIVE SESSION:

At 9;48 p.m., Bird made a motion to go into Executive Session under 2.1-344, Section A-6, Code of Virginia, to discuss Personnel Matters. REGULAR SESSION:

At 10;35 p.m., Kapp made a motion to go back into Regular Session,

the motion carried.

In Regular Session, Bird made a motion that Lyssa Whitfield be appoined to the Haymarket Planning Commission, this was seconded by Kapp, the motion carried.

ADJOURNMENT:

With no further bussiness, Bird made a motion at 10;38 p.m. to adjourn the meeting, seconded by Kapp, the motion carried.
