All members were present at the January 16,1989 Town Council Meeting also attorney Turner T. Smith. It opened at 8 p.m., with a Prayer and Pledge of Allegiance. The minutes of the December, 1988 meeting were read and approved with one exception, a referral was made to the County Fire Chief and it should have been the Fire Marshall. The Treasurer reported a balance of \$73,933.41 in the General Account at the end of December, 1988. Councilman John Kapp made a motion to pay the following bills.

BUSINESS LICENSES:

John Kapp made a motion to grant a Business Licance to Gregory A. Hartle, trading as; Southern Pacific Contracting, Ina. at 6640 Jefferson St., (office #13), nature of business is Contracting, this was seconded by Bird who mentioned that no vehicles would be left there as Mr. Hartle would be driving his home at night. The motion carried unanimously.

Councilman Michael Krebs made a motion to grant Thelma A. Keener, trading as Allrite Insurance Agency, Inc., a business license. Her office will be at 14910 Washington St. (office #4), the nature of the business will

be Insurance Sales. This was seconded by Bird and approved.

Tim L. Everett, who has recently started operating Gossom's Hardware, under the same name, submitted a application for a Business License, explaining that he didn't know if Allen Gossom's would be good until April, 1989 or not. Council didn't feelthat one was needed but Mr. Smith informed them that one would be needed. His application

was approved but the charge will be \$25.

Brian McGann wanted a Business License for McGann Stone Masonry at his home at 14740 Washington St., the nature of business will be stone masonry. The reason he needed the license was because in order to get his County License, he first needed one from the Town of Haymarket. Bird made a motion to grant him one, seconded by Kapp, the motion carried. Mr. McGann was told that no trucks except his own coulc be kept on the premises.

Lorene Payne spoke on the Town of Haymarket Survey and submitted copies to the members of the Town Council ad Mayor Bean. She mentioned that a Boy Scout Troop who needs to ear merits will deliver them and pick them up. There will also be boxes at Town Hall and Gossom's Store that they could be deposited in. Freeborn made a motion to have copies of the Survey printed to pass out in Town, seconded by Krebs, the

motion carried. Lorene Will get bids on the printing.

Mrs Payne also spoke on the Article 12 Amendments. A copy is attached to these minuted. To hold Public Hearings, approval oc Council was necessary. Bird made a motion to hold a Joint Public Hearing, seconded by Kapp the motion carried. This will be a Joint Public Hearing with Council and the Haymarket Planning Commission. She also wanted to contact John Rohrbaugh and discuss the amendments with him. Bird made a motion to have Lorene Payne contact Mr. Rohrbaugh regarding the Article 12 amendments, this was seconded by Kapp, the motion carried and permission was granted.

MAYOR BEAN:

Mayor Gertrude Bea n read a letter from Mr. Smith saying that the Virginia Municipal League Letter of Dec. 8,1988, having to do with a proposal before the Virginia General Assembly that would allow towns with populations less than 3,500 to give their law enforcement authority

Including the authority to enforce local ordinances, to county sheriffs.

Bird made a motion to write a letter to them saying the Town is satisfied with our present Police situation and the Town Police and County Police

working together, this was seconded by Kapp, the motion carried. HAYMARKET DAY:

Charles Coe and Jack Dunlop arreared before Council to talk about Haymarket Day which the Gainesville Ruritan Club will be sponsoring. It is just in the Planning Stage and they have a proposed date of Sept. 16, 1989. They will be reporting back to Council on a regular basis.

COUNCIL MEMBERS AND OTHERS:

Freeborn mentioned that it seemed like we are paying double for inspections at Longstreet Commons since we already have John Berger doing inspections. Lorene Payne said that Berger does the Building Inspections but we need someone elce to do Site Inspections. Payne said that they had to be a Civil Engineer. Freeborn at this point asked William Green if he was a Civil Engineer and he answered that he was.

Kapp had several questions, one was about Town and Country Auto and wanted to know if they had cleared their lot yet? Officer Damron replied

that they had.

He also asked about Jetco and Officer Damron said he had spoken to them and if he catches them with any violations he will issue them a summons. He suggested notifying Mrs Evans that she needed a sign permit.

Kapp also wanted to know if the Highway Dept. is coming out to talk to Council?Bird replied, before asking them, we must be specific as to what we want to discuss with them. It was decided that Lorene Payne and Bird would get together and decide whaat to ask the Highway Dept.

The last question Kapp had was to ask Green if he was going to

finish the doors in Town Hall? Green answered that he was.

It was mentioned that April 9-15 will be National Volunteer Week and Haymarket should thing about it and if they would want to do anything on it?

William Green said that on Postal Holidays, the Council should also take the Holidays.

EXECUTIVE SESSION:

At 9;20 p.m., Bird made a motion to g into Regular Session the motion carried.

In regular session, Kapp made a motion to pay Officer Amos Damron Intermin Insurance, the amount being \$231 per month., this was seconded by Krebs and the motion carried unanimously in a Roll Call Vote Bird was going to look into an Insurance Package Deal, also would get job discriptions for the Police Dept., and get back to Council by the next meeting.

ADJOURNMENT:

With no further business, Kapp made a motion to adjourn the meeting at 9:36 p.m., seconded by Bird, the motion carried.
