When the November 21,1988, Haymarket Town Council meeting began with a Prayer and Pledge of Allegiance at 8 p.m., two Council Members were absent, Richard Bird and James R. Gossom.

Minutes of the October meeting were read and approved. Also the minutesof the Public Hearing on October 17,1988 on the Rezoning of the Rohrbaugh property were approved. The Treasurer reported a balance in the General Account on October 31,1988, of \$75,086.63. The following bills were presented to Council.

1. HAYMARKET SERVICE CENTER, WORK ON POLICE CRUISER---\$27.00

2. Holladay's Market, Gas. Police Cruiser (sept WNO HALL 23.82 Councilman Kapp made a motion to pay them, seconded by Councilman Michael Krebs, the motion carried unanimously in a Roll Call Vote.

VIRGINIA POWER FRANCHISE:

The Virginia Power Franchise for 30(Thirty) years was to be approved but since no bids from the Company had been received, it had to be held up for a short time, Kapp made a motion to accept the Franchise subject to receiving a bid from them, this was seconded by Councilwoman Terri Freeborn, the motion carried in a Roll Call Vote. The Town Clerk was to notify Virginia Power to get their bid in.

REZONING: The Rezoning of the eight(8) acres of the Rohrbaugh property on Washington Street was discussed. The Mayor asked that it be tabled for 4-6 months, or Council could vote on it and turn it down, then they could re-apply. Mr. Virtanen who was present for this said they would rather wait than to have to re-apply. The Mayor then replied that after Consultant Lorene Payne had a chance to look the Comprehensive Plan over, etc. and get back to Council, Mr. Virtanen would be notifies.

LORENE PAYNE: Mayor Bean said she would like to put Lorene Payne on as a parttime employee of the Town. Freeborn made a motion to hire Lorene Payne part time, seconded by Krebs, this was unanimous in a Roll Call Vote, therefore the motion carried.

BUSINESS LICENSE:

Freeborn made a motion to grant A & W White a business license to operate a business at 15161 Washington St., the nature of the business was to be Commercial Site Development , Sewer & Water. Dennis Wrye was on hand to receive it. JETCO, INC.

Ron Young from Jetco, Inc. appeared before Council to ask permission to keep their Business Trailer on the property for a longer time since their year had run out. The time limit asked for was for another year as they didn't know how long they will be there. Mrs Freeborn didn't think another year should be granted as she didn't think it was reasonable. Freeborn and Krebs were against the year's extension; Kapp and Crouch were in Favor of it. Mayor Bean was the tie breaker and voted to let them keep the trailer there for another six (6) months. MAYOR BEAN:

Mayor Bean announced that Stella Ollinger from the Symphony Orchesta wanted someone from Council to be in a Concert(they wouldn't have to do anything, just be there). Freeborn was going to contact her about it. TRASH CONTRACT

Everette Bean from Bean's Trash Service was present at the meeting. Since the landfill fees have goe up so much, Mr. Bean needs an increas. It seems that in order to do this, it must be advertised for bids.

PARKING LOTS:

Parking lots in Town were discussed. The question came up as to whether they had to be blacktoped or if gravel could be laid. Alan Gossom who was present said the Town's Zoning Ordinance did not read tha they had to be blacktoped unless they were new buildings or addition. Mr. smith said that in order to make them blacktop them, they had to be either new building, additions or conversions. COUNCIL MEMBERS AND OTHERS:

Mr. Glenwood Bear suggested getting some cushions for the seats in Town Hall. Also he felt Council should hold meetings twice a month.

Officer Amos Damron mentioned that heis getting complaints about customers parking in front of Matthews Restaurant . The Mayor will try to talk to Walt Berg over the week-end.

EXECUTIVE SESSION:

At 9:40 p.m., Freeborn made a motion under section 2.1-344, A-6 of the Code of Virginia to go into Executive Session to discuss Personnel Matters, this was seconded by Krebs, the motion carried. REGULAR SESSION:

At 10;25 p.m., Kapp made a motion to go back into Regular Session,

seconded by Krebs, the motion carried.

In regular session, it was agreeded that the Town Clerk was to set up a Special Meeting and notify Mr. Mackey of Cablevision and Willaim Green, Chairman of the Planning Commission to attend. Also Cablevison was to be advised not to hook up their tower until some problems were resolved as to the location where the tower was to go, etc. Freeborn made the motion on this, seconded by Crouch, approved by Kapp and Krebs abstained from voting, therefore the motion carried. ADJOURNMENT:

With no further business, Kapp made a motion to adjourn the meeting at 10;35 p.m., the motion carried.
