

All members of Council were present at the Oct. 17, 1988 Haymarket Town Council Meeting when it began at 8 p.m. with a Prayer and Pledge of Allegiance.

Minutes of the Sept. meeting were read and approved. The Treasurer reported a balance of \$76,195.59 in the General Account at the end of Sept. Councilman Kapp made a motion to pay the following bills;

1. Haymarket Service Center, Work on Police Cruiser----\$84.49
 2. Gossom's Hardware, items for T. H. & Police Dept.-----\$ 5.86
- this was seconded by Councilman Bird and the motion carried unanimously in a Roll Call Vote.

PARKING ORDINANCE:

Mayor Gertrude Bean asked if everyone had had a chance to read the new Parking Ordinance and the reply was yes. Bird mentioned the new Subdivision will have to either have signs or curbs painted yellow to indicate no parking. He then made a motion to adopt the new Ordinance, seconded by Kapp, the motion carried unanimously in a Roll Call Vote. A copy of the Ordinance will be sent to Florida to the Municipal Code Corp. to be added to the codification of the Town's Ordinances.

BUSINESS LICENSES:

1. Kapp made a motion to grant Daniel Entsminger, trading as; It's Stained Glass, nature of Business, Retail Glass Goods, at 6620 Jefferson St. the old Utterback House. This was seconded by Councilman James R. Gossom, the motion carried.

2. Bird made a motion to grant James A. Gossom a Business License for Gossom's Seal Coating, the nature of Business will be to Seal and Repair Driveways, this will be located at 14851 Washington, St., this was seconded by Councilman Kapp, and the motion carried.

COPIER:

A copier to be purchased for Town Hall was discussed. Several were presented. Councilman Sam Crouch made a motion to buy the Panasonic Copier, seconded by Bird, the motion carried unanimously in a Roll Call Vote.

PLANNING COMMISSION:

Bird made a motion to accept Michael Herman to the Planning Commission, seconded by Kapp, the motion carried.

MAYOR:

Mayor Gertrude Bean announced that Lorene Payne would be in Town Hall on Monday night, Oct. 24, at 7 p.m. and asked all that could to attend stating that Mrs Payne can clarify some difficult things on the Town's Zoning Book

The Mayor read a letter stating that Macon Piercy and Mullins are planning to put up a project outside the Town's limits. Councilwoman Freeborn felt the Town should give their input on this.

PARADE COMMITTEE:

Some members of the Parade Committee were present at the meeting and told Council it will be a Town Activity and presented a list of their Officers. Chairman is Bob Mayer, Vice Chairman, Leon Kernes; Treasurers, Sharon Wolford and Joanne Clifton; Secretary, Bob Mayer. Mayer stated we should start planning now for the Town's bi-centennial. Also the Dept. of Transportation have approved the closing off of the road from Gainesville School to Town Hall for the Parade. The Halloween activities will be between 11 a.m.-4 p.m. Freeborn made a motion to accept the Committee, seconded by Krebs, the motion carried.

COUNCIL MEMBERS:

Councilwoman Terri Freeborn would like to have someone from the Highway Dept. meet with Council.

Councilman Kapp spoke about the trailers piled up on the corner of 55 & 15 and wanted to know if anyone knew what was going on? The Mayor said it will be checked on.

Councilman Bird spoke on the County Wide Fire Levy and explained it to everyone present.

EXECUTIVE SESSION:

Freeborn made a motion at 9:28 p.m. to go into Executive Session under Section 3.1-244 ,A-6 under the Code of Virginia.

REGULAR SESSION:

Krebs made a motion to go back into Regular Session at 10:12 p.m., seconded by Kapp.

IN REGULAR SESSION:

Kapp suggested rezoning of the eight acres of the Rohrbaugh property be put off until discussed with Mr. Smith. This will come up at the Nov. meeting.

ADJOURNED:

With no further business, the Oct. meeting adjourned at 10:15 p.m.
