

The August Haymarket Town Council Meeting began at 7:15 p.m., with the Prayer and Pledge of Allegiance. Present were Sam Crouch, Terri Freeborn, John Kapp, Michael Krebs and Attorney Turner Smith. Minutes of the July 18, 1988 meeting were read and approved. The Treasurer reported a balance of \$69,271.04 in the General Account at the end of July, 1988. Councilman John Kapp made a motion to pay the following bills;

1. Haymarket Service Center, Oil Change, Oil Filter, Police Cruiser-\$18.58
2. C'S PRINTING SERVICE, ENEVELOPES, LICENSE FORMS, ZONING BOOKS-- \$809.90
3. HOLLADAY'S MARKET, GAS, POLICE CRUISER-----\$107.05
4. GOSSOM'S HARDWARE, ITEMS, POLICE DEPT. & TOWN HALL-----\$ 18.25

this was seconded by Councilman Michael Krebs, the motion carried in a Roll Call Vote.

SHARON'S THRIFT SHOP:

Sharon Wolfrey appeared before Council to ask permission to set some of her items from the Thrift Shop outside, she will make them look neat, explaining unless she does this, her sales are lowered. She was granted permission but asked to try not to leave items out over night.

HAYMARKET SHADE SHOP:

After being approved by the Haymarket Planning Commission, Freeborn made a motion to grant the Haymarket Shade Shoppe permission to put up a sign on their business at 14950 Washington Street, the cost to be \$22.80. Seconded by Krebs, the motion carried unanimously.

VIRGINIA POWER:

Mayor Gertrude Bean told Council that she recently had a meeting with several representatives from Virginia Power in regards to renewing the Town's Franchise with them. Council had previously voted to renew it for 5 years instead of the 40 years they requested. Virginia Power feels that the lowest they can go is 30 years. William Green suggested asking them if over a period of time, they would consider putting the lines underground, before renewing it for 30 years. The Haymarket Town Council asked Attorney Turner Smith if he would call them and discuss the Franchise with them.

HOLLADAY'S MARKET:

Holladay's ,arket applied for a Business License to operate a Barbeque Pit outside the store. At the present time they are working with the Health Dept. Mr. Smith said they would need a license from the Town, since it is a separate business from the store. Councilman John Kapp made a motion to grant them a business license subject to receiving a letter from the Health Dept. approving it, this was seconded by Councilwoman Terri Freeborn, the motion carried unanimously.

CABLEVISION:

Mr. Bill McGolrick from Cablevision addressed Council on the Tower they wish to put up at Century Stairs property. It will be 190-210 feet. Council turned it over to the Haymarket Planning Commission to study and report back to them.

U.S. CENSUS JOBS:

The Mayor read a letter from the Bureau of the Census, U.S. Department of Commerce regarding temporary jobs in the fall taking census. Literature on this will be left in Town Hall.

COUNCIL MEMBERS:

John Kapp mentioned he had conferred with Virginia Nalls regarding her Adult Home on Madison St. At the present time they have to back up on neighbor's property to turn around when leaving the premises. Kapp went on to say he would probably have more on this later but hopefully it will be resolved as her Lawyer Mike Vanderpool is working on it. Kapp also spoke briefly on incinerators. With so much talk about trash dumping, etc. going on in the area, he felt if the Town had any input on it, incinerators would be the way to go in the future.

Crouch told Council that behind Holladay's Market is an eyesore with so many trucks and cars parked there. Freeborn said they should apply for a zoning Variance or they should be made to move the. The owners of Holladay's Market, John Beiler and Dwight James who were present said they would ask them to remove the vehicles. It was suggested that perhaps they could park them on Jetco's property if they could get the owner's permission.

Krebs made a motion that if they can't relocate in Town, the money received from the truckers for Town Tags should be refunded, this was seconded by Freeborn and the motion carried. They will have 30(thirty) days to vacate the property at Holladay's Market.

MEETING PLACE:

The Mayor read a letter from John Goolrick, an assistant to Rep. French Slaughter, who would like a meeting place once a month to meet with constituents. The day has not been set up as yet. Kapp made a motion to let them meet in Town Hall, seconded by Freeborn, the motion carried.

ADJOURNMENT:

With no further business, Freeborn made a motion to adjourn the meeting at 8:20 p.m., seconded by Kapp, the motion carried.
