

HAYMARKET TOWN COUNCIL MEETING-JUNE 20, 1988

The June 20, 1988, Haymarket Town Council Meeting began at 8 p.m., with a Prayer and Pledge of Allegiance. All members of Council were present except for James R. Gossom who was hospitalized. Attorney Turner Smith was also present.

Minutes of the April Meeting were read and approved. There was no Council meeting in May due to a lack of quorum. The Treasurer reported a balance of \$57,886.37 in the General Account at the end of May, 1988. Councilman Richard Bird made a motion to pay the following bill.

1. Gossom's Hardware, Items for Town Hall.---\$8.17.

this was seconded by Councilman Fewell Melton and carried unanimously in a Roll Call Vote.

MAYOR BEAN:

The Mayor read a letter of Resignation from Michael Krebs. He resigned from the Board of Zoning Appeals to accept his seat on Council. Melton made a motion to accept his resignation, seconded by Bird, the motion carried,

FIRE PREVENTION CODE:

Councilman and Fire Chief Richard Bird spoke on the State Wide Fire Prevention Code, saying as long as the Town of Haymarket has been here, it has had a good record concerning fires. Councilwoman Terri Freeborn made a motion to adopt the Code, seconded by Richard Bird, the motion carried unanimously in a Roll Call Vote. As to how it will be enforced will be determined at the July meeting.

CERTIFICATES:

Tom Beane from the Electoral Office gave out Certificates to the Mayor and Council Members elected in May, 1988.

VARIANCE:

It was announced that a Variance had been granted to Church Street Associates by the Board of Zoning Appeals for the house at 6600 Fayette Street, (Lot C-1).

BONNIE & CLYDES

After the Planning Commission approved a Sun Deck, 10 x30, to be added to Bonnie & Clydes Sub Shop and Richard Bird announced that the Fire Dept. would give them a letter stating that the Fire Dept. would provide them with extra parking spaces on their property, Bird made a motion to approve the Sun Deck, seconded by Freeborn, the motion carried.

SIGNS:

Richard Bird made a motion to approve the sign for Sharon's Thrift Shop, seconded by William Utz, the motion carried.

Mrs Evans on Madison St. wants to put up two signs on her Country Store, but first she must show proof that she has complied with the Highway Dept. concerning her entrance to the property.

BUSINESS LICENSES:

Some Business Licenses were granted;

1. Richard Bird made a motion to grant Joseph Waggoner a Business License to operate Bull Run Cable, at 15020 Wash. St.(office #3), this was seconded by Melton, the motion carried.

2. Freeborn made a motion to grant Barbara Bohnet a Business License to operate an office for Allstate Insurance Co., 15026 Washington St. This was seconded by Bird, the motion carried.

3. Melton made a motion to grant Gloria Robinson a Business License to operate the Haymarket Pharmacy, LTD at 6611 Jefferson St., this was seconded by Utz, the motion carried.

4. Bird made a motion to grant Roger Armstrong a Business License to operate a Mobile Food Service in Town trading as ".Do It Right", seconded by Freeborn, the motion carried.

5. The Business License for Allen Elkins was asked by Allen Gossom to be put on hold until the next meeting.

FRANCHISE

Bird made a motion to grant Virginia Power a Franchise for Five(5) years instead of renewing it for Forty(40) years, this was seconded by Utz and the motion carried unanimously. Members of Council thought a forty (40) year Franchise was too long. Attorney Smith mentioned that since it was only for Five(5) years, no advertisement was necessary.

RURITAN CLUB

Chuck Dedi from the Gainesville Ruritan Club spoke to Council, asking what the club could do for the Town? They now have about 25 members and he thought perhaps holding a Haymarket Day in Town would be good. He was informed by Council Members that it would be greatly appreciated.

ASAP

Kimball Peele from ASAP introduced Mrs Vanzanna who wants to represent Haymarket on the Board that ASAP is setting up. She lives in Hickory Grove. A Resolution was to be signed that calls for at least an annual report. Freeborn made a motion to have Mrs Vanzanna represent the Town of Haymarket, seconded by Utz, the motion carried. Freeborn also made a motion to adopt the Resolution, seconded by Utz, the motion carried.

BID

A bid was read from Bob Nichols in regards to black topping the Parking Lot at Town Hall, the price being \$4,200. This was put on hold for awhile.

REZONING

The Application for Rezoning of the property of James L. Revis from R-(Residential) to B-1(Business) was given by Council to the Haymarket Planning Commission.

BEAN'S TRASH SERVICE:

Councilman Utz spoke about Bean's Trash Service. Since the fees at the Landfill had gone up, he wanted to give Everett Bean \$125. more a month. His contract will have to be checked on first as it may not be allowed until it comes up for renewal, then bids will have to be taken.

EXECUTIVE SESSION:

At 9:40 p.m., Bird made a motion under 2.1-344 ,Section A-6 to go into Executive Session to discuss Personnel Matters.

REGULAR SESSION:

At 10:33 p.m., Melton made a motion to go back into Regular Session. At that time Bird made a motion to make Officer Amos Damron a full time Town Police Officer, this was seconded by Freeborn and the motion carried.

Melton then made a motion to give Damron a fifteen percent (15%) raise over \$16,000. (Sixteen Thousand) which would make his salary Eighteen Thousand, Four Hundred (\$18,400.) a year, this was seconded by Utz and the motion carried unanimously in a Roll Call Vote.

The new rate schedule for transactions in the Town of Haymarket were presented to Council by Chairman of the Planning Commission, William Green, representing the Planning Commission. A new list of fees will be hung in the Haymarket Town Hall. Freeborn made the motion to accept the new fees, seconded by Utz, the motion carried.

ATTORNEY SMITH:

A letter which was read and passed out by the Mayor concerning a list of fees from the Town Attorney Turner T. Smith were unanimously accepted.

ADJOURNMENT:

With no further business, the meeting adjourned at 10:40 p.m.
