

When the Sept. 21, 1987, Haymarket Town Council meeting began at 8 p.m., with Mayor Gertrude Bean leading with a Prayer and Pledge of Allegiance, all Council Members were present.

Minutes of the August 17, Haymarket Town Council Meeting and minutes of the Special Meeting on Aug. 19, to go over the draft of some new proposed Zoning Ordinances, were read and approved.

The Treasurer reported a balance in the General Account of \$40,334.66 and \$95.67 in Revenue Sharing, at the end of August, 1987. Bird made a motion to pay the following bills;

Councilman Sam Crouch seconded the motion and it was unanimously approved in a roll call vote.

DOOR, TOWN HALL

Crouch made a motion to accept William Green's proposal for \$950 (Nine Hundred and Fifty Dollars) to put up an inner door at Town Hall, this was seconded by Councilwoman Terri Freeborn and unanimously approved in a roll call vote.

TURNER SMITH

When Mayor Bean announced that Attorney Turner T. Smith was beginning his 28th year as the Town's Attorney, Mr. Smith received applause from a grateful group of people in Town Hall.

GUEST SPEAKER

Diana Weand from the Soil and Water Conservation District was guest speaker at the Sept. meeting. Mayor Bean read the letter of understanding between the Town and the Soil and Water Conservation District. Bird made a motion that Mayor Bean sign it, seconded by Freeborn and approved in a roll call vote. Miss Weand left a handbook on the subject, \$25 (Twenty Five Dollars) was to be mailed for it.

BUSINESS LICENSES:

1. Richard Bird made a motion to grant Chris Cole a business license to operate Haymarket Millwork(stair Manufacturer) at 15151 Washington St.(Behind Century Stairs) . This was seconded by Councilman William Utz and approved.

2. Business License for Bobby and Wilda Smith to operate a mobile canteen trading as Country Kitchen, in the Town, was not approved.

BUILDING PERMITS:

1. A Building Permit which had previously been approved for Travis Key to build a house on William Utz's property was granted.

2. Dr. Weaver's Building Permit which also had been approved by the Town Council at the Aug. 17, 1987 meeting was granted after the Planning Commission approved it.

3. Councilman Bird made a motion to grant Alan Gossom 2 Building Permits for small additions to his property at 15000 Washington St., after they had been approved by the Planning Commission, this was seconded by Councilwoman Terri Freeborn and unanimously approved.

4. The Preliminary Plat for the Townhouses(Longstreet Commons) was approved by the Planning Commission. Councilman William Utz made a motion that Council approve the Preliminary Plat, seconded by Bird. The Planning Commission and the Town Council will now wait for the final plans and a letter from the Highway Dept.

5. Steven Bean received permission to build an addition to the garage and remodeling of it, at 6712 Jefferson St. after being approved by the Planning Commission, Freeborn made a motion to grant it to him, seconded by Bird and approved.

OTHER NEWS

1. COUNCILWOMAN Freeborn asked for a status on the Noise Ordinance in Town. She mentioned that there was quite a bit of noise late at night which she believed was coming from Century Stairs.

2. Attorney Turner Smith was asked to check over the proposal on the Ordinance Codification from the Municipal Code Corp. Bird made a motion that if Mr. Smith approved it, that it be signed and returned, this was seconded by Freeborn and unanimously approved in a Roll Call Vote.

3. Attorney Smith was asked what could be done about the dangerous ditch on Jefferson St.? He replied he could file a Mandamus with the Highway Dept., to fix it, stating what the Town wanted done and a specific time for it to be done. For this Mr. Smith suggested the Town giving him copies of previous letters sent to the Highway Dept., a map to show where it is and if possible, a picture of it. Bird made a motion for Mr. Smith to send the Mandamus, seconded by Freeborn and unanimously approved.

4. Freeborn made a motion for the Town to join the Prince William County Municipal League, seconded by Bird and approved.

5. Councilman Melton asked about the Waterworks. Mayor Bean replied, the last she heard from Mr. Proctor, they will be making the study soon.

6. Glenwood Bear asked if the sewerage system was being tested in the Town at the present time and the answer was yes. Mr. Bear also mentioned several other items, he had a tree fall on his property and there was another one on Madison st. that should come down, he was afraid it might fall on someone. He also asked Chief Boston to check on speeders on Madison St.

JOINT PUBLIC HEARING

A Joint Public Hearing will be held on Oct. 19, 7:30 p.m., on the new proposed Zoning Ordinances. It was to be advertised 2 times in the Journal Messenger.

MOPEDS

William Green spoke on kids in Town on Mopeds, the noise and danger of them.

CHIEF BOSTON

Chief Boston made a request to purchase some items from D.M. V. for his safety program. The Town would have to put up the money for them, but would be reimbursed later for the money spent. In a roll call vote, Council voted unanimously against purchasing the items.

EXECUTIVE SESSION

At 9:25 p.m., Councilman Richard Bird made a motion under section 2.1-344 under the Code of Virginia to discuss Personnel Matters. This was seconded by Councilman Fewell Melton and approved.

REGULAR SESSION

At 9:55 p.m., Councilwoman Terri Freeborn made a motion to go back into Regular Session, seconded by Bird.

IN REGULAR SESSION

In regular session, Freeborn made a motion not only to refuse Chief Boston's current project but felt he should be advised not to spend time on any more projects until he checked with Council and had their approval. This was seconded and approved.

ADJOURNMENT:

With no further business, the Sept. meeting adjourned at 9:58 p.m.
