HAYMARKET TOWN COUNCIL MEETING MARCH 16,1987

The March 16,1987, Haymarket Town Council meeting began at 8 p.m., with Mayor Gertrude Bean leading with a Prayer and Pledge of Allegiance. When Roll Call was taken, all members of Council were present with the exception of Richard Bird.

Minutes of the Special Meeting held on Feb. 5 and minutes of the regular meeting held on Feb. 16 were read and approved. The Treasurer reported a balance of \$27,667.50 in the General ACCOUNT and \$346.24 in Revenue Sharing at the end of February. Councilman Fewell Melton made a motion to pay the following bills;

1. HOLLADAY'S MARKET \$67.03(GAS FOR POLICE CRUISER)

2. C'S PRINTING SERVICE (ZONING BOOKS & TAXATION FROMS)\$103.95

3. MANASSAS CAR WASH (POLICE CRUISER)\$4.50

4. COUNTY OF PRINCE WILLIAM (COMMUNICATIONS REPAIR)\$25.00

5. GOSSOM'S HARDWARE (ITEMS FOR P.D. & T. H.)\$10.15

This was seconded by James Gossom and unanimously approved in a roll call vote.

FIRE INSURANCE

Councilwoman Terri Freeborn made a motion to raise the Fire Insurance on Town Hall from \$48,000 to \$75,000 and \$10,000 on the contents in Town Hall. This was seconded by Councilman William Utz and unanimously approved in a roll call vote.

BUSINESS LICENSES

Jetco, Inc. applied for a business license for specialized hauling at 15241 Washington Street and they also wanted to use an office trailer for Administrative offices. Officer William Boston stated that they had taken the large trailer off the wheels and secured it. Town Attorney Turner Smith informed Council that unless the trailer could be considered an Assesary Building, it could not be allowed legally unless the Town's Ordinance was changed. No action was taken on the business license since the trailer was listed on it.

BUILDING PERMITS

Ronald Hancock of 14950 Madison Ct. asked permission to build an attached Garage. The work was to be completed by Oct. 1987. Melton made a motion to grant it to him, seconded by Utz and umanimously approved.

No action was taken on a Building Application submitted by Carmello Intelisano to add on to an exsisting building at 14890 Washington St. The reason being that the Town Council had no plans on it and the Chairman of the Planning Commission was not present. When reached by phone, Chairman William Green recommended that Council approve the plans but they couldn't do it without a copy of them.

SIGN PERMIT

Michael Goettelman asked permission to put an 18X24 metal sign up on his business, Small Engine Trading Post, at15000 Wash. St. Councilman Sam Crouch made a motion to approve it if the Planning Commission approves it, this was seconded by Councilman James Gossom and unanimously approved.

CHIEF BOSTON

Chief William Boston reported that he had purchased the two new tir for the Police Cruiser and also the seat in the cruiser had been recovere by Mastercraft Home & Auto Upholsters. He also mentioned that Lisa Bailey wanted to know if Council wanted her to mow the lawn at Town Hall again this year?

EXECUTIVE SESSION:

At 8:45 p.m., Terri Freeborn made a motion under Section 2.1-344 of the Code of Virginia to go into Executive Session to discuss Personnel Matters. This was approved.

REGULAR SESSION

At 9:25 p.m., Melton made a motion to go back into regular session, seconded by tz and approved.

In regular session, it was announced that the Building Inspections would be raised fro \$25 to \$35 per inspection. Melton made the motion on this, seconded by Gossom and unanimously approved.

Adjournment

With no further business the meeting adjourned at 9:40 p.m.
