HAYMARKET TOWN COUNCIL MEETING

FEBRUARY 16, 1987

All members of Council were present at the Feb. 16, 1987, Haymarket Town Council meeting which began at 8 p.m. with a Prayer and Pledge of Allegiance. Attorney Robert Bendall was present in the absence of Town Attorney Turner Smith. Minutes of the January meeting were read and approved. The Treasurer reported a balance of \$18,295.46 in the General Account and \$574.02 in Revenue Sharing at the end of January. Councilman Richard Bird made a motion to pay the following bills;

1. Manassas Car Wash- \$4.50 (Washing Police Cruiser)
2. Gossom's Hardware-\$7.67 (items for Police Dept.)
3. Holladay's Market-\$77.00 (Gas for Police Cruiser).

This was seconded by Councilman Fewell Melton and unanimously approved in a roll call vote.

BERNARD PROCTOR

Bernard Proctor, a Consulting Engineer, addressed the Town Council about HUD Grants. In order to apply for one, a new survey would have to be taken and a Public Hearing held. Most of the residents in Town would have to be on a low to moderate income, this means up to \$19,250 for one person; \$22,000 for two; \$24,750 for three and under \$27,500 for a family of four. These grants could be obtained for water and other items. Bird said he would like to have a grant to extend the sewer line however he didn't think the Town would be ready to discuss any grants until the Mid-Summer grants came into effect. It was also mentioned, like the case of the sewer grant from HUD, the Community must put up some of the money for the project.

BUSINESS LICENSES

Mr. Vernon Taff received a Business License to operate an Automotive Repair Shop in the rear of 14920 Washington St. (Lane's Motors). Bird made the motion to grant it, seconded by Councilman Sam Crouch and unanimously approved.

Joe Greer received a Business License to operate Joe Greer Plumbing and Heating, Inc. at 15001 Washington St. (Kruse House). pffoce #1. Bird made the motion on this, seconded by Councilman James Gossom and unanimously approved.

MAYOR

Mayor Gertrude Bean read a letter from Mr. Wilmer Hutchison asking if the Town would like to raise the Fire Insurance on Town Hall. Richard Bird suggested that we check with him to find out the cost of \$100,000 on Town Hall and \$10,000 on the contents.

POLICE CHIEF BOSTON

Police Chief William Boston said he would need a new tire for the Police Cruiser to get it through inspection. He had gotten three prices on it, in Leesburg, it would be \$72.50, in Fredericksburg, \$51.56 and \$45.00 on Gallows Rd. & Lee Highway. Bird made a motion that Chief Boston purchase two new tires so to balance the Cruiser better, this was seconded by Councilman Crouch and unanimously approved in a roll call vote.

Next the Chief informed Council that the seats in the Police Cruiser needed to be recovered. Mastercraft Upholsters in Haymarket had offered to do it and also to build up the front seat as it should be in a Police Cruiser, giving the Town Ten Percent off the regular price. Bird made a motion to approve this, seconded by Crouch and unanimously approved in a roll call vote.

Councilwoman Terri Freeborn made a motion that Chief Boston be allowed to purchase a Fingerprint Set for \$39.95 and a Backing Sheet for \$10.75, this was seconded by Bird, unanimously approved in a roll call vote.

SIGN PERMIT

Bird made a motion that Joe Greer be allowed to place a 4X4 sign on his Plumbing Business at 15001 Washington Street, provided it was approved by Chairman of the Planning Commission, William Green, this was seconded by Freeborn and approved.

COUNCIL MEMBERS:

Mr. Melton had several questions; first he wanted to know how a person could obtain house numbers and he was informed that the County will give them. Richard Bird volunteered to secure any house numbers needed. Next Mr. Melton mentioned he would like to see Haymarket get more for the Business Licenses. Attorney Bendall told him they could raise the Business Licenses to \$30 or they could go by Gross Receipts. Bird mentioned he would rather go for the #30, not Gross Receipts as it would involve too much paper work. No action taken on this. Mr. Melton also wanted to know if anyone requesting a Special Meeting could be charged for it. The Attorney said he didn't think it could be done. Melton made a motion to have him research it, seconded by Bird and approved.

CARPETING


It was decided by the Mayor and the Town Council to have the color "Pecan" carpeting put into Ton Hall.
