## DECEMBER 15,1986

All Council members except Sam Crouch were present at the Dec.15,1986 Haymarket Town Council Meeting, which began with a Prayer and Pledge of Allegiance at 8 p.m. Minutes of the November meeting were read and approved. The Treasurer reported a balance of \$18,435.73 in the General Account and \$574.02 in Revenue Sharing at the end of Nov. Councilman Richard Bird made a motion to pay the following bills; Manassas Car Wash, 4.50; Holladay's Market, \$70.26; Gossom's Hardware, \$30.54 and Kustom Electronis, Inc. \$37.50, this was seconded by Councilwoman Terri Freeborn and approved in a roll call vote.

BUSINESS LICENSES

Mr. Bird made a motion to grant Shelia Ballenger a business license to sell fruit at Holladays Market, seconded by Councilman Melton and unanimously

approved.

After a letter was read by Dr. Weaver asking that Doctor Adelaida G. Guieb be granted a business license to join his practice at the Haymarket Medical Center, Bird made a motion to grant her the business license after her application and \$25 fee was received. This was seconded by Melton and unanimously approved.

TELESAT CABLE T. V. In regards to releasing the \$300,000. Construction Bond fro Telesat, Mayor Bean read a letter from the Prince William Service Authority stating it was alright with them to release it but another letter from Virginia Power asked the Town not to release it until they had had time to make inspections. Mr. David Vitalis said that Telesat had just received word from Virginia Power saying inspections were completed. Richard Bird also stated that he had made inspections with Telesat and the system was up and working and they had met all the criteria. Bird made a motion to release the Bond upon hearing from Virginia Power, this was seconded by Freeborn and approved.

PLANNING COMMISSION

Mayor Bean read a letter of Resignation from Dennis Wrye of the Planing Commission, dated Nov. 20,1986. Melton made a motion to accept Wrye's

resignation, seconded by Utz and ananimously approved.

Richard Bird announced that the Planning Commission has approved the easement on the Paxton Property and a letter from the Highway Dept. had been received. Bird made a motion to accept the changes to the Entrance to Melton Drive, to line up with Madison St., this was seconded by Melton and approved. Then Bird made a motion to have the Mayor sign the easement, seconded by Gossom and approved.

MAYOR BEAN

Mayor Gertrude Bean read a letter from the First Virginia Bank

thanking Chief Boston for his services to them.

A letter from the Commonwealth of Virginia, Dept. of General Services, was read concerning an "Errors and Ommissions" Insurance for the Town, the fee would be \$750. a year. Mr. Smith had looked it over and advice the Town to take it. Bird made a motion to take the insurance, seconded by Melton and unanimously approved in a roll call vote.

The Mayor asked Council what they thought about taking the money Judge Stickley had put in the First Virginia Bank and fixing up TownHall? This inculede; storm windows, indoor-outdoor carpeting, double fronTdoors,

AN inside door, and vacumn cleaner. Bird made a motion to do it, also to take the Judge's stand out to have more room. Melton seconded it and it was approved. Bird will take bids on the work.

POLICE DEPT.

Chief Boston reported that the Uto Grave Yards in Town are being cleaned up. Bird mentioned that signs were needed to be put up at the Town's limits as the Police hief is losing cases in Court because they are not there, they should be put on Rt.15, both ends of Jefferson St. and on Rt.66. Mr. Smith said the Highway Dept. would put them up. Bird will check with them.
