

HAYMARKET TOWN COUNCIL MEETINGJANUARY 20, 1986

The Haymarket Town Council Meeting on Jan. 20, 1986, began at 8 p.m. Councilwoman Terri Freeborn who had become a new Mother the day before was absent. Mayor Gertrude Bean had a short Prayer and Pledge of Allegiance. The minutes of the December meeting were read and approved. In the Treasurer' Report, there was a balance of \$14,233.21 in the General Account and \$726.43 in Revenue Sharing at the end of Dec. Councilman Richard Bird made a motion to pay the Multi-Peril Insurance, in the amount of \$164., seconded by Councilman Fewell Melton and approved in a roll call vote.

LETTERS:

Mayor Bean read a letter from the Prince William Citizen's Bond Referendum Steering Committee, notifying Haymarket of two meetings to be held on Jan. 23, at 7:30 p.m. in the Board Room of the Prince William Board of Supervisors and on Feb. 6, at 7:30 p.m., at 9250 Lee Ave. in Manassas.

PIPE STEM PLAN

Macon Piercy and Ellen Wilson, co-owners of the property at 6661 Fayette St., requested the Town Council to approve a Pipe Stem Plan, they want to divide two lots, one would contain 11,000 square feet and the other 11,243 square feet. The purpose of the request was to build one house on each lot. This was referred to the Planning Committee who will report back on it to Council at the next meeting.

MAPS

Councilman Bird reported the maps are still being worked on and should be ready by the next meeting.

REIMBURSEMENT

Mr. Melton made a motion that the Chairman of the Planning Committee receive Thirty Dollars per meeting, this was seconded by Councilman William Utz. There was a roll call vote on this in which Mr. Bird voted no and the other four members present voted yes, therefore the motion carried. Mrs Bean also said this would hold true for John Berger when he had to go to Richmond, etc on Town Business as it had already been approved to pay Mr. Berger for his expenses.

AMOS DAMRON

Amos Damron, who had submitted an application for the job of Police Sergeant, addressed Council, told of his previous experience and his desire to remain in Police Work and how much he wanted to work for the Town.

MEETING PLACE

William Green notified Council that he is trying to establish a local Chapter of the Veterans of Foreign Wars and wanted to know if they could meet at Town Hall aor the present time. The Mayor said she would check on it with the Town's Attorney but she didn't think it could be done.

DENNIS WRYE'S PROPERTY

Garnett Johnston appeared before Council with plans for a Sub-division on Dennis Wrye's property to be named Lincoln Court, the owners to be Mike Heslop and James Shadak. Each of the five lots would be about 12,000 square feet, with a well for each one. This has been referred to the Planning Committee who will report back as soon as possible.

ORNDOFF'S PROPERTY

Mr. Lee Hensley stated to Council that he wants to purchase Orndoff's property but not the Corporation. He mentioned that the Health Dept. said that as long as there were no violatios, he could keep the

Restaurant open until a new one is built. Councilman Richard Bird was opposed to this, stating he didn't think it could be done. The matter will be checked on with the Town Attorney.

TELESAT CABLE T.V.

Mr. Vitalis from Cable T.V. was present and stated they would like to start working on it within 45 days and have the system completed in 6 months. Richard Bird made a motion that it be granted after the Town Attorney reviews it and says it's alright. This was seconded by William Utz and approved.

PUBLIC HEARING

Dennis Wrye asked about advertising a Public Hearing for the purpose of changing the zoning in some district of the Town to include apartments. It was decided to advertise it once a week for 2 weeks and the Joint Hearing with Council and the Planning Committee be held on Feb. 17, at 7:30 p.m. prior to the regular meeting.

EXECUTIVE SESSION

Councilman Utz made a motion at 8:50 p.m. to go into Executive Session under section 2.1-344 of the Code of Virginia to discuss Personnel Matters, this was seconded by Councilman Bird.

REGULAR SESSION

At 9:10 p.m. , Mr. Bird made a motion to go back into regular session, seconded by Mr. Utz.

In regular session, Councilman Sam Crouch made a motion to try Amos Damron for 6 months as the new Police Sergeant in Haymarket. Mr. Utz then asked Mr. Damron if he would give Council 6 months to observe him, then they would meet and talk over his benefits connected with the job. He replied that he would. After this, Councilman Utz seconded Mr. Crouch's motion to hire Damron for 6 months trial, this was unanimously approved. Damron was to turn in his resignation at George Mason University, giving them 3 weeks notice.

ADJOURNMENT

Richard Bird made a motion at 9:35 p.m. to adjourn the meeting, seconded by Sam Crouch.
