

SPECIAL HAYMARKET TOWN COUNCIL MEETING

SEPTEMBER 25th, 1984

The Special Called for Haymarket Town Council Meeting of Sept. 25, 1984, began at 8 p.m. All Council members were present. Vice Mayor Gertrude Bean led the group in a prayer and Pledge of Allegiance.

First on the Agenda was read a letter from Dennis Wrye, Chairman of the Planning Commission in which he stated that the term of William Green expired September 20, 1984 and needed to be extended for another year until Sept. 20, 1985. Mrs Crewdson made a motion to extend Mr. Green's term for one year but since it was not seconded, the motion failed.

Next, it was asked that one of the Council members take Anne Smith's place on the Planning Commission but there was no response. Councilman Bird made a motion that the whole issue contained in the letter be postponed to the next meeting, this was seconded by Councilman James Gossom and approved, by the rest of the Council with the exception of Councilwoman Crewdson who voted No since she felt the time would not make any difference in their opinions.

Next Mrs Crewdson said that she would like to post the names of those who owed delinquent taxes on the door of Town Hall and to also send them certified letters giving them 30 days to pay. Mrs Crewdson put this into motion, seconded by Mr. Gossom and approved.

Mr. Bailey who has recently moved into Madison Acres addressed the Council about all the discrepancies concerning the house he purchased, the builder being Jim Brown and asked if the Town could do anything to help him. He plans to take the builder to Court in 60 days. He was advised that Haymarket operates under the State Code. Mr. Wrye told Mr. Bailey that he had talked to Mr. Proctor from State and he would send an inspector out to go over things with Haymarket's Building Inspector and Mr. Bailey. There will be no charge for the State Inspector. Mrs Crewdson made a motion to have the Inspector from Richmond come which was approved. Mr. Melton was to contact Mr. Proctor to send the Inspector out and also to send Richmond John Berger's name.

Macon Piercy asked several questions about building several houses. He was told that Council determines who gets building permits and that he must obtain them first and then deal with the Building Inspector.

At 9 p.m. Mrs Crewdson made a motion to go into Executive Session under 3.1-244 of the Code of Va. to discuss Personnel matters.

Then at 9:30 p.m., Councilman Bird made a motion to go back into regular Session, seconded by Councilman Melton and approved. At this point Mr. Melton made a motion to hire John Berger for all inspections, in Town such as building, electrical, plumbing, etc.

Attorney Turner Smith drew up the following Ordinances:

" AN ORDINANCE TO ESTABLISH A FEE SCHEDULE FOR BUILDING INSPECTOR "

Be it ordained by the Council of the Town of Haymarket in special

CALLLED SESSION THIS 25th day of Sept., 1984, that there shall be paid by any person requiring an inspector of any building to pay to the town an inspection fee of twenty-five dollars (\$25) for each such inspection.

Mr. Melton made a motion to accept the ordinance, seconded by Mr. Gossom and unanimously approved.

It was decided at the Sept. 25th meeting in regular session to send Officer Donn Fasick a letter of suspension without pay on the basis that he has failed to work 40 or more hours per week, failure to appear at Council Meetings, failure to check in with Mr. Orndoff when on duty and failure to notify the County Police when going on or off duty. The motion for this was made by Mr. Melton, seconded by Mr. Bird, 5 members voted for it with Mrs Crewdson abstaining saying that she felt badly that Council hadn't given Officer Fasick specific duties to be carried out. Fasick was to be put on suspension without pay as of Sept. 25,1984.

With no further business, the meeting adjourned at 9:55 p.m.
