

HAYMARKET TOWN COUNCIL MEETING--JULY 16, 1984

The July 16, 1984 Haymarket Town Council meeting began at 8 p.m. with the new Mayor, Hugh Orndoff presiding. Roll call found all members of Council present including Mr. Bird and Mr. Melton who were recently elected. After the Pledge of Allegiance, the minutes of the June meeting were read and approved. Treasurer Gertrude Bean reported a balance of \$15,425.29 in the General Account and \$1,442.15 in Revenue Sharing at the end of June. She also stated that Veeco was still sending bills for the installation of street lights that were installed several years ago in the amount of \$430.36, which is questionable. The Mayor was to contact them.

Councilwoman Lois Crewdson made a motion that a resolution be adopted which would state that Prince William County Police and the Town of Haymarket Police have concurrent jurisdiction in enforcing state law. This was seconded by Councilman Richard Bird and unanimously approved. Therefore the Town of Haymarket adopted the resolution, the draft of which was presented by Lt. William Hunt.

Mrs Crewdson gave a list of bids she had collected for either painting or putting siding on Town Hall. Councilman James Gossom asked that the decision on this be postponed until the August meeting in order to get more information and to have a carpenter look over the damage to the building.

Mr. Wrye reported that the proper forms were sent to both Mr. Bolt and Mr. Reuter but neither of them have returned them. Alan Gossom stated that Mr. Bolt had received his but was not in a hurry to proceed at this time.

Appointments were made at the July meeting; Mr. Bird made a motion to appoint Don Fasick as Chief of Police, seconded by Mrs Bean and approved; Mr. Melton made a motion to appoint Turner Smith as Town Attorney, seconded by Mr. Bird and approved; Mr. Melton also made a motion to appoint Mrs Bean as Vice Mayor, seconded by Mr. Bird and approved.

Mayor Orndoff presented a plan to Council that he would like to create a job that would enable someone to be in Town Hall on a regular basis to do the job of Treasurer, Town Clerk, to work on the ordinances, etc. Mr. Melton made a motion to approve the job, seconded by Mr. Bird and approved. Fewell Melton made a motion to hire Dorothy Keller for the job, seconded by Richard Bird and approved. Then Mr. Melton made a motion to have Pete Hamlett audit the Treasurer's Books, this was seconded by Mr. Gossom and approved. In regards to the ordinances, after they are completed, a committee will be formed to look them over. Mrs Bean and Mr. Bird agreed to confer with Mrs Keller as to the hours of the new job and the salary.

Mrs Crewdson asked the Mayor if he can make up an agenda before meetings. She stated that it would be a great help. Mr. Orndoff will try to do so.

Mr. Orndoff asked if it is legal for the Town to buy gas from his station? Mr. Smith thought that this was allowable since the statute does not apply to Town the size of Haymarket, but it's not advisable. However he will check on it further and send Mr. Orndoff a letter regarding it.

Mr. Melton made a suggestion that a follow up be done on the sewer connections in the Town.

With no further business, the July meeting adjourned at 9:24 p.m.
