A Public Hearing/Regular Meeting of the Mayor and Council of the Town of Haymarket, VA, was held this evening in the Council Chambers, commencing at 7:00 PM.

Mayor Kenneth Luersen called the meeting to order.

I. Call To Order

II. Pledge of Allegiance

Mayor Ken Luersen introduced Scout Troop 924 to lead in the Pledge of Allegiance.

III. Invocation - Pastor Allen Smith, Haymarket Baptist Church

Mayor Luersen introduced Pastor Allen Smith from Haymarket Baptist Church and asked him to give the evening's invocation.

IV. Haymarket Day Recap

Town Planner Emily Kyriazi gave a brief update on the recently held Haymarket Day. Mrs. Kyriazi recognized the Long Street Commons crew who put in countless hours in making each Haymarket Day a successful event. She named and recognized each person individually.

Mrs. Kyriazi recognized Scout Troop 924 and thanked them for all their help in keeping the trash receptacles empty and especially with assisting the vendors in packing up in the midst of the rain storm. She presented the Troop with a donation to help with summer camp and any other activities that they may do this year.

Mrs. Kyriazi also recognized Park Valley Church and thanked them for all the children's activities that they organized and manned in the Town Park. She presented the church with a donation check for their involvement with the event.

Mayor Luersen recognized and thanked the Town Staff for the countless hours that they did for making Haymarket Day a successful event. The Mayor also recognized family members of the staff who also volunteered their time.

Councilwoman Ramirez addressed the current Farmer's Market end date and asked if the Town Council would consider one of the vendors using the Town Parking Lot for pick up of pre-orders through out the off season. A discussion followed on the subject. After the discussion, Town Planner Emily Kyriazi suggested that she work with Councilman Ramirez and Vice Mayor Pater to discuss and come to a decision on what would be best for the community. The Town Council agreed with Mrs. Kyriazi's suggestion.

4. Police Department

Councilwoman Ramirez stated that she realized the police department report was generated prior to Halloween. Mrs. Ramirez asked Chief Sibert for a report regarding Halloween. Chief Sibert shared that he, his family and Officer Coppage drove through the communities and

handing out candy from the cruisers to the children and interacted with the public. He stated that it was very well received. Councilwoman Ramirez thanked Chief Sibert for his involvement and for sharing his family with the community for the event. Councilwoman Ramirez inquired if there could be more officer involvement for such events. A short discussion followed on the subject. Councilman Pasanello asked Chief Sibert and Town Manager Coon to share information on the upcoming polar plunge and torch run. Chief Sibert stated that law enforcement actively supports the torch run every year that benefits Special Olympics. Chief Sibert stated that he and Mr. Coon is organizing a team for the polar plunge in February 2022 along with the torch run in June 2022. He stated that he has gathered some fundraising ideas and will be putting those together in the near future.

Mayor Luersen asked about the comment made during citizens time on providing lock boxes for the businesses so that emergency personnel has access to the building. Chief Sibert stated that the boxes that were referred to during citizens time is more likely used with fire and rescue personnel. There was a short discussion on the subject. Mayor Luersen asked for the Chief and Councilman Morris, who is the police liaison, to discuss the subject and come back with a recommendation at a future meeting.

Lastly, Mayor Luersen congratulated Office Burgoon for training and obtaining his bicycle patrol certification.

X. Agenda Items

1. Consideration of Ordinance 2021-002: Zonting Text Amendment

Town Planner Emily Kyriazi lead the discussion on the Zoning Text Amendments and the proposed edits. Mrs. Kyriazi handed out a list of suggested changes that was brought to her attention since the Planning Commission public hearing. Discussion ensued on 58-3.1: delinquency accounts; 58-20.9: Sidewalks - to incorporate the language for stamped concrete sidewalks; 58-2.12: Hotels - striking the 60 foot height since its no longer applicable; add an inoperable vehicle section and change language on the single family parking; 58-6.1 BZA - edits made that was suggested by Town Planner Kyriazi. Discussion followed on subjects such as commercial vehicles parked in residential areas, traffic impact analysis in Section 58-3.2- those qualified to conduct a traffic analysis study, and 58-9: fence heights. The Council asked Town Attorney Crim about approved SUP's being grand fathered. There was also a discussion on time limit of an approved SUP. The Council also asked the Town Attorney on if time limits can be set on approved SUP's. Mr. Crim stated that generally language is put into the ZTA that if an SUP has not commenced within a particular time, then the SUP expires and the process would start over. There was also a discussion on notifications requirements. There was also a discussion on coverage regulations. There was also a discussion on shared parking regulations. There was a discussion to reinstate the time limits for acting on an approved Certificate of Appropriateness granted by the Architectural Review Board. Town Attorney Crim gave some recommendations on time limits for the COA.

After the discussion on the various edits, Town Planner Emily Kyriazi stated that she would bring the final edited version to the November Work Session for final review prior to the adoption at the December Regular Meeting.

Councilman Weir moved to defer further consideration of the ZTA until the November Work Session. Councilman Pasanello seconded the motion. The motion carried.

3. Shop Small Event

Town Manager Chris Coon shared that when the Town did the shop small event last year using Cares Act Funds, the Town had an agreement with Prince William County IDA. Mr. Coon asked the Town Council to authorize him to sign the contract agreement with PWC IDA for the shop small event again this year. A short discussion followed on the subject.

Councilwoman Ramirez moved to a not to exceed amount of \$17,500 from Cares Act and ARPA funds for the purpose of the Town of Haymarket Shop Small Event. Councilman Pasanello seconded the motion. The motion carried by a roll call vote.

Without objection, the Town Council directed the Town Manager to sign the agreement with Prince William County IDA.
