A Special Meeting of the Mayor and Council of the Town of Haymarket, VA, was held this evening in the Council Chambers, commencing at 7:00 PM.

Mayor Kenneth Luersen called the meeting to order.

I. Call To Order

II. Agenda Item

Mayor Luersen stated that the only item on this evening's agenda was to adopt the FY24 budget. He gave the floor to Town Treasurer Roberto Gonzalez. Mr. Gonzalez stated that before the Town Council was the final FY24 budget. He stated that the only modification was an increase in revenue with the additions of new tenants with all the monies would go to the Maintenance line item on the expenditure side.

1. Resolution #2023-011- Adopt and Appropriate FY24 Budget

Vice Mayor Pater moved that the Haymarket Town Council adopt Resolution #2023-011: a resolution to adopt the annual operating budget and capital improvement budget, and to make an annual appropriation of the budgeted amount for the Fiscal Year beginning July 1, 2023 and ending June 30, 2024. Council Member Pasanello seconded the motion.

Council Member Leake stated that he hopes in the future that the Council would continue to eliminate the tax burden on the Town residents as more revenue comes into the Town. **With no further discussion, the motion carried by a roll call vote with 3 in favor and 1 opposed.**
