A Work Session of the Mayor and Council of the Town of Haymarket, VA, was held this evening in the Council Chambers, commencing at 6:00 PM.

Vice Mayor TracyLynn Pater called the meeting to order.

I. Call To Order

1. Closed Session Motion


With no further business before the Town Council, Councilman Weir moved to adjourn with a second by Councilman Pasanello seconded the motion. The motion carried.
